AGENCY'S DISCUSSION AND ANALYSIS

Agency Overview

USC Lancaster serves six area counties and admits all students who show promise of academic success. Most of USCL's students are first generation college students from rural areas, small towns, and cities across the central Piedmont area of the Carolinas. Through a broad commitment to equity, an extensive scholarship and financial aid program, a variety of weekday and evening course offerings, and online degree completion programs, USC Lancaster seeks to make education accessible, affordable, and convenient to the residents of this area.

USC Lancaster has always provided a strong foundational education for area students, but in recent years, the campus has also significantly expanded four-year online degree completion offerings to provide greater opportunities for current and future students in and beyond our service area. The campus offers two general Associate Degrees, one in Arts and another in Sciences, in addition to specialized Associate degrees in Business and Criminal Justice, and an Associate in Technical Nursing available through a partnership between USCL and York Technical College. As the Palmetto College campus with the strongest enrollment in four-year degree completion programs, USCL also currently offers students five new Palmetto College degrees, for a total of nineteen bachelor's degree options. Most notably, in Fall 2018, the campus opened a new satellite site in Indian Land to better serve education needs of residents in our northern service area.

In pursuit of the campus's primary mission, teaching excellence remains the highest priority at USC Lancaster. Students at USCL have access to approachable and well-qualified faculty and staff members, expansive technological support, and academic and personal support services, as well as opportunities for internships and learning beyond the classroom. Faculty, staff, and students alike participate actively in community and public service, and the campus is a hub for local and regional community events. The Gregory Family YMCA provides equipment and programming to campus and community to keep residents of Lancaster and the surrounding areas of all ages active and healthy.

The campus administration works closely with the USC Budget Office and the Administration of Palmetto College to adjust and strengthen campus funding and to serve as a good steward for legislative funding. The campus is grateful for strong community support, with regular funding from the city and county, and from the local Educational Foundation of USC Lancaster.

Agency Highlights

- Continued excellence in teaching, advising, and student support programs.
- Rapid response to the Novel Coronavirus (COVID-19) pandemic allowed the university to provide academic continuity of instruction in Spring and Summer 2020 and to reopen safely in Fall 2020.
- Strong retention rate of 53.1%, the highest of the Palmetto Colleges campuses.
- Consistently strong faculty scholarship activities.
- Significant growth in engaged community partnerships.
- A community-based launch 60th anniversary celebration of USC Lancaster's opening, including
 a first-ever alumni tailgate party, a series of events for campus and community, and expanded

The campus was proud to contribute to community health with our largest class of Bachelor of Science in Nursing graduates in Spring 2020, with 24 new nurses graduating, and we are in the early stages of exploring new partnerships with MUSC.
- In its recent 2020 rankings of Best Community Colleges in South Carolina, Niche.com ranked USC Lancaster ranked No. 1, and in its 2020 rankings of Best Community Colleges in the nation, Niche ranked USC Lancaster No. 2.

Agency COVID-19 Response

USC Lancaster moved both rapidly and deliberately to respond to the Novel Coronavirus (COVID-19) pandemic. On March 11, 2020, during Spring Break for students, the University of South Carolina adjusted the academic schedule and operations university wide, including the Palmetto College Campuses:

- Classes were cancelled for the week after Spring Break, March 16-22: this action gave faculty a
 week to begin the process of transitioning their classes online and prevented a major health
 risk by keeping students at home, rather than risking the return of thousands of students to
 their home campuses.
- Face-to-face classroom instruction was suspended, initially for a period of two weeks, which was then suspended throughout mid-August. All USC Lancaster courses were held online for the remainder of the spring semester and for the summer as well.

• University operations were shifted to remote work for all but essential personnel. Daily health screenings were required for any employee to visit campus.

The university's quick response to the rapidly growing pandemic mitigated the risk to students, faculty, and staff; USC Lancaster has worked closely with sister Palmetto College campuses and with UofSC to develop strategic reopen plans which allow for a flexible and rapid response to changing circumstances.

Community Health and Safety

On every UofSC campus, our enduring priorities are the health of students, faculty, staff, and our communities as we limit and mitigate the spread of the virus while maintaining our campus's mission of academic, research, and athletic excellence while sustaining the university. USC Lancaster has worked closely with local government, community health and wellness non-profits, MUSC and local health care providers, and DHEC and the CDC to inform all planning efforts and to mitigate risk. All decisions discussed in the sections below support this primary mission. In addition to developing a comprehensive USC Lancaster Campus Reopen Plan, administration also participated in the development of and is guided by the policies and best practices laid out in the USC Palmetto College Reopen and Risk Mitigation Plan. Both units continue to be supported by the campus safety and public health Novel Coronavirus (COVID-19) guidance established by the flagship Columbia campus, whose planning efforts include our senior leadership.

Academic Continuity

USC Lancaster provided support to all instructional faculty for a successful transition to remote learning for students in three primary ways. First, USCL faculty have access to UofSC Center for Teaching Excellence. In consultation with the CTE, the Office of the Provost created an extensive Keep Teaching webpage with resources for modifying courses, including providing remote individual consultations with faculty and a robust series of webinars on teaching and assessment strategies, and accessibility to provide all students equal access to academic success. This ongoing support was critical for faculty success in the transition. Second, many USCL faculty stepped up to support colleagues who were less experienced with online instruction; the campus owes a great debt to those individuals who generously shared their expertise to contribute to the best possible learning experience for our students as they handled their own courses. And third, the university formed six planning and preparation teams to create clear guidance for the return to face-to-face instruction in August, including an Academic and Student Affairs teams which created detailed protocols for safe instruction and classroom interaction.

Students were able to complete their courses, with Spring 2020 graduates recognized in a virtual commencement ceremony. Students also had the option of requesting pass/fail grades at the conclusion of the semester if they struggled in the transition so their academic records would not be negatively affected. Finally, all campus offices transitioned student support efforts to provide the same outstanding support USCL always offers; tutoring, counseling, and advising services were offered by video, and virtual chat established for all key offices, including student life, admissions, financial aid, and the business office. USC Lancaster is proud of our faculty's and staff's outstanding commitment to the academic success of our students.

Budget Impacts

Because of careful budget management and because of the nature of our institution, USC Lancaster was financially positioned to weather the COVID-19 crisis in FY20 without a significant impact to campus operational funding. The key refund categories reported at larger university campuses, primarily housing and meal plans, are not income streams at USC Lancaster so no students needed refunds issued for these services. Minimal tuition refunds were issued due to the transition to online instruction. Expenses included Personal Protection Equipment (PPE), sanitizing supplies, the installation of safety barriers and signage, and educational supplies (such as home laboratory kits for science students and IT equipment to facilitate remote instruction), along with some additional personnel costs. For example, given the top priority of the health and safety of our campus community, USC Lancaster has employed a nursing professional to assist with COVID-19 matters this academic year.

The campus carefully monitors revenues and expenditures in normal circumstances and is even more carefully reviewing budgets to leave the campus well positioned not only to weather the COVID-19 pandemic but also to continue stable growth beyond. Consequently, budget estimates included in this report are estimated very conservatively. While strategically expanding enrollment efforts, the campus has also planned for a decline in enrollment to avoid any negative financial impacts. The campus has experienced some minor loss of revenue related to community events, since public use of campus facilities has been suspended since March 2020. Currently USCL is hiring only mission-critical positions and is evaluating other options to address potential budget shortfalls. Palmetto College Salary Study compensation adjustments should remain in effect, since employee compensation is an important goal of the institution. Proposed pay plan and fringe benefit increases have been withdrawn for now. The campus has been allocated \$285,431 by Coronavirus Aid, Relief, and Economic Security (CARES) Act; these funds cover expenses incurred due to the COVID-19 pandemic and potentially supplement lost revenues due to lower enrollments. CARES Act funds will be distributed to the campus in FY21.

The university is grateful for the continuing support of the South Carolina legislature, particularly in the continuing resolution to maintain state agency funding levels in FY21 at the FY20 rate, while monitoring for any possible mid-year budget reductions.

Report Restructuring

The University of South Carolina Lancaster is concluding a year-long strategic master planning process, which the campus has conducted while working with the City of Lancaster on its Revitalizing Downtown Lancaster master planning process. In addition, University of South Carolina President Bob Caslen has just launched a system-wide new strategic plan, For South Carolina: A Path to Excellence, which included Palmetto College representation and which the campus looks forward to supporting. As USC Lancaster works to align these various strategic plans, and in an effort to provide support to the South Carolina Department of Administration's development of new dashboards focusing on agency's most significant data points, and finally, in response to the COVID-19 pandemic crisis, the campus has chosen to streamline 2020-2021 state agency accountability performance measures to include top-level agency goals only, with corresponding strategies and measures, and to set targets conservatively. Those measures from USC Lancaster's 2019-2020 performance measures template that are no longer included in this report are still important metrics but will be monitored internally by the appropriate departments. USC Lancaster looks forward to continuing to support the South Carolina Department of Administration's efforts to make information about key program areas and expenditures more accessible to the public.

Strategic Planning Goal 1

Attract, inspire, challenge and enable our students to become innovative thinkers and transformative leaders.

Key Strategies: Increase enrollment, retention, and graduation rates in service of providing an outstanding educational experience to USC Lancaster students.

- Continued success in maintaining or exceeding enrollment:
 - Summer 2019 enrollment reached 439, consistent with the previous summer's high of 446.
 - Fall 2019 enrollment reached 1640, a strong 7.68% growth over the previous fall's enrollment of 1,523, a result of increased recruiting and growth in dual enrollment.
 - Spring 2020 enrollment reached 1,414, an increase of 3.89% over the previous spring's enrollment of 1,361.

- Maintained a strong scholarship program for students demonstrating academic excellence and/or financial need.
 - o In 2019-2020, 181 students were awarded a total of \$197,716.50 in scholarship funds.
 - The Educational Foundation has 156 scholarship and other special purpose funds. The campus typically adds two new scholarship funds per year, but in 2019-2020, generous donors established five new funds, likely as part of our 60th anniversary campaign.
- Continued offering events for campus and community that highlight creative and innovative thinking, including featuring and recognizing student and faculty research, innovation, and creativity.
 - Campus has hosted 7 formal events featuring creative and innovative events, including student research and poster presentations, student performing arts events, and a faculty sabbatical lecture.
 - The Native American Studies Center Lunch and Learn program has totaled 2,758 visitors since its launch in 2013.

Strategic Planning Goal 2

Enable students to become innovative thinkers and transformative leaders by providing access to a wide range of academic experiences and programs led by excellent faculty in an innovative, diverse, equitable, and inclusive campus culture.

Key Strategies: Prepare students for the challenges and opportunities of the 21st century by offering a wide range of academic experiences and programs taught by excellent faculty, and by preparing them to flourish as citizens in a diverse culture.

- Continued recruitment and advising support for Palmetto College degree completion program students.
 - In Fall 2019, USCL had 103 students enrolled in our signature degree completion programs, the Bachelor of Liberal Studies and the Bachelor of Organizational Leadership.

- Continued success in recruitment and support for the new Indian Land location, launched Fall 2018.
 - USC Lancaster has now offered a total of 31 general education courses serving 202 students in the rapidly growing urban northern end of our service area.
- Continued service to area high school students and their families by offering an affordable entryway into college coursework with dual enrollment courses.
 - o USC Lancaster's dual enrollment program grew in Fall 2019 by 22.3%.
- Completed the first full year of Palmetto Pathway, a gateway program in which 54 USC
 Lancaster students were housed and taught in Columbia to provide greater educational access
 to state residents. Students are taught by Palmetto College faculty and provided student
 services by Palmetto College in this one-year (30 hour) program, after which successful
 students then matriculate to a four-year program/campus.
- Continued success in recruiting, retaining, and supporting an excellent faculty.
 - In 2019-2020, the campus hired two new tenure-track faculty and was proud to recognize the success of one faculty member promoted to full professor and another promoted to associate professor and tenured. In addition, nine faculty were appointed to the rank of senior instructor.
 - Maintained stable funding of faculty and staff development resources to provide students with access to high caliber expert faculty, funding the USCL Research and Productive Scholarship Program at \$40,000 and the faculty travel budget at \$30,000.
- Continued commitment to creating a diverse and inclusive campus climate.
 - o A diverse student body with 29.2% minority enrollment by race/ethnicity in Fall 2019.
 - USCL hosted over a dozen diversity related cultural and community events, including programming presenting faculty scholarship on desegregation and race relations in the Lancaster community.
 - The campus formed a new Diversity, Equity and Inclusion Committee with six subcommittees addressing areas including Student Recruitment, Faculty Recruitment, Student Groups and Activities, Campus Cultural Activities, and Academic Courses and Programs. These groups began meeting in August 2020.
- Strengthened student experiential learning program infrastructure.
 - Hired Internship Coordinator, developed formal internship onboarding process, researched and procured a career services platform for internship and job searches called Handshake, which will be brought online in 2020-2021.

Key Strategies: Maintain campus infrastructure and financial stability to provide a well-equipped learning environment and strengthen financial condition, efficiency, and operations of USC Lancaster

- Continued strong community partnerships offering events for campus and community that highlight creative and innovative thinking
 - In the 2019 calendar year, USC Lancaster's Native American Studies Center attracted
 7,439 visitors.
- Continued development of partnership opportunities.
 - The campus received \$670,311 in gifts and grants in 2019.
 - A 60th anniversary commemorative brick campaign resulted in donors purchasing 68 bricks, generating a profit of over \$13,000.
- Continued fiscal stewardship towards operating within budget, meeting financial objectives and building reserves to sustain the campus in economically challenging times. This requires careful allocation of all revenue sources, which include tuition, the Palmetto College revenue sharing model, and potentially recurring parity funding and deferred maintenance monies.
 - As of the June 2020 review, USCL reported budgeted resources at 100.3% and year-todate uses at 98.4%. FY20 tuition revenue came in at 101.2% of budget.
 - The campus entered FY20 with a carry-forward balance of \$2,656,226. These funds are dedicated to the long-term goal of rebuilding reserves to sufficiently cover three months of campus operating expenses, or \$2.6 million.
 - The Lancaster County Commission for Higher Education distributed \$1.6 million to the campus in FY20, \$500,000 more than FY19.
- Continued work on current open maintenance and physical plant projects, including the following:
 - Starr Hall fire alarm, ceiling tile/grid abatement and replacement (reviewing scope)
 - Medford Library and Hubbard Hall elevator repairs (reviewing scope)
 - Bradley Arts & Sciences Building physics lab renovation (complete)
 - Hubbard Hall roof replacement (complete)
 - Gregory Center natatorium windows replacement (in progress)
 - o Hubbard Hall main parking lot resurfacing (in engineering and design phase)

It remains a top priority at USC Lancaster to make education affordable for students and to increase access to education. This includes a dedication to responsible stewardship of the resources entrusted to us by the State of South Carolina in appropriations and by our students in tuition revenues. The bulk of campus expenditures are in our general operating funds, primarily the unrestricted E&G funds reported in the program below, and primarily in personnel and fringe benefits. Campus facilities maintenance, upgrades, utilities, and equipment costs also represent a significant portion of campus expenditures, including capital projects.

USC Lancaster is most grateful for the generous support of the South Carolina State Government and for the many partners and donors in our community and beyond who allow the campus to provide excellent facilities to students and community members. USCL strives not only to be a responsible steward of the financial resources of our students, community, and state, but also in return to contribute strongly back.

Data Metrics

Please note that some campus metrics in the Strategic Planning and Performance Measurement Template have been adjusted due to changes in data reporting standards implemented by the USC Office of Institutional Research, Assessment, and Analytics (OIRAA). These are noted in the metrics in the Data Source and Availability cell. Additionally, a number of 2019-2020 performance measure metrics were affected by COVID-19; for example, Visits to the Native American Studies Center (3.1.1) and Community events offered on the USC Lancaster campus (3.1.2) were both lower than projected given the physical closure of the campus from March until August. These impacts are projected to be short-term.

Data Entry Online Form

USC Lancaster has responded using the new data entry web form to the question concerning manual entry of data, which is intended to identify redundant data entry processes across state agencies. USC Lancaster consulted with Ann Bryson-Eldridge, the Performance and Accountability Manager for this state agency accountability report, with colleagues in the Palmetto College system, and with the University of South Carolina Office of Institutional Research, Assessment, and Analytics. It was determined that because the Palmetto College campuses data-entry systems are internal within the larger University of South Carolina system, none of our data-entry processes move across agencies as the intent of this question suggests. This includes the following:

• student data such as transcripts, admissions, enrollment, which is available across all USC system campuses through our Banner enterprise student data system;

- financial data such as employee travel, payment requests, procurement requisitions and accounts payable, etc, which are also managed through PeopleSoft Finance system.


Data in the larger University of South Carolina system may move across agencies in the way this report requests, and those data-entry process will be addressed by the University of South Carolina Columbia.
