AGENCY'S DISCUSSION AND ANALYSIS

Resilience: the ability to recover from or adjust easily to misfortune or change (Merriam-Webster)

This fiscal year, 2020-2021, has been a year that has tested the resilience of everyone, perhaps especially those in higher education. The COVID-19 pandemic forced the University to learn to operate in an environment where students are more likely to take online courses and faculty prefer to teach courses online to avoid sickness. The faculty, staff, administrators, and students at USCB were able to step back and adjust to the required changes and still excel, despite the difficulty.

Fall 2020 enrollment took an expected dip to just over 2,000 students, a decrease of more than 100 students. For a small institution, every student enrollment matters, and the decrease required the University to take a deep look at the financials and spending trends and identify areas where already tight budgets could be tightened further without sacrificing the quality of the education and services provided to students and the community. Through restructuring, temporarily leaving vacancies open, and monitoring expenditures across the institution, USCB was able to survey the financial stress and provide top-level education to all students in face-to-face, hybrid, hi-flex, and online modalities. As the stresses of the pandemic lessened for the Spring 2021 semester, it was important to transition as many students as possible back to on-campus education, because research has shown that face-to-face interactions not only improve student learning, but they improve the student experience outside of the classroom and make students more likely to participate in extracurricular activities as well as internships and experiential learning. These out-of-the class learning opportunities are requirements for many of our programs at USCB, and they serve to improve student learning within their majors and understanding of possibilities after college. In many cases, these internships and experiential learning opportunities lead to employment offers even prior to graduation.

Through targeted recruitment activities and increase interactions with prospective students, Fall 2021 enrollment at USCB will reflect a 17.6% increase in New Freshmen and a 24.5% increase in New Transfer students (both over Fall 2020 levels). This increase reflects a return to near Fall 2019 enrollments for these two groups after suffering significant decreases in Fall 2020. Unfortunately, the decreased enrollment in Fall 2020 will continue to impact USCB enrollment for several years. Because we had 100 fewer students, and because we graduated slightly more students than in previous years, the pool of students who had not graduated and could return was smaller than usual. Even with consistent retention, we would necessarily be down by about 60-75 students for Fall 2021. Because of the tireless work of our Enrollment Management division and our faculty's and staff's efforts contact all students to encourage them to return, along with stronger dual enrollment presence than in previous years, USCB's Fall 2021 enrollment is likely to be higher than it was in Fall 2020.

The emergence of new programs, changes in delivery models, and new COVID-related challenges facing students, faculty, and staff are realities in a new paradigm. The changes were exacerbated by enrollment decline. The rapid pace of technological innovations, while a benefit to many, has disproportionately impacted lower income students and has had the effect of widening the socioeconomic divide. USCB understands that it must stand poised with a modern structure that enables the University to support the success of all students and respond to current and future challenges, while being highly efficient in uncertain times.

Calendar year 2020 and Spring semester 2021 were extremely challenging due to the Coronavirus pandemic. In March 2020, the University of South Carolina Beaufort moved all courses and programs online in order to keep employees safe from the virus. As a result of the interruption of

normal college functioning and campus life, enrollments decreased significantly, resulting in university-wide budget deficits. Dr. Panu held a campus-wide meeting to communicate the impact that the loss in tuition revenue has had/will have on the University. The President and Board of Trustees encouraged the Senior Comprehensive Universities to review efficiency measures including exploring all cost-cutting and operational efficiency possibilities and investigating new revenue streams.

As a result, Academic Affairs undertook a major investigation into its current organizational structure with an eye toward efficiency and improving services to students, faculty, and staff. The reorganization of Academic Affairs at USCB was developed as a result of the feedback from a Working Group with representatives from across the division, as well as input from the Chancellor, the Provost/EVCAA, Deans, Department Chairs, Program Coordinators, and other faculty. The feedback provided was incorporated into a new model with nine departments that report directly to the Provost/EVCAA, rather than reporting to the Provost/EVCAA through academic schools as they did previously.

As reflected in the USCB Mission statement, the University exists for two groups: its students and the citizens of the Lowcountry of South Carolina. This dual aim defines the fundamental mission of universities historically. Thus, at the core of its mission, the University strives for two things: to graduate well-prepared students and to enhance the quality of life in its service area. If USCB were unable to continue growing its academic programs, enrollments, and continuing education, artistic, and cultural offerings, the impact on the people of the region and the state would be significant. The quality of life in the region would be greatly diminished as the availability of qualified employees entering the workforce decreases, continuing education and lifelong learning opportunities become

practically non-existent, and cultural activities that are crucial to the region's residential and tourist appeal are significantly cut.

Necessary key interventions of the General Assembly that would help prevent such a catastrophe center on financial and capital support. Even before the impact of COVID-19 on the University's enrollment and associated revenue, historically, USCB has received the lowest state appropriations per in-state student FTE of all SC comprehensive institutions. This is in part an artifact of insufficient state appropriation increases as the institution transformed from a two-year campus to a comprehensive university. Despite the lack of parity, research conducted by Dr. Robert T. Carey, director of the Regional Economic Analysis Laboratory at Clemson University, and Dr. John Salazar, former director of the Lowcountry & Resort Islands Tourism Institute at USCB, estimated USCB's total economic impact in Beaufort County at \$122.4 million. For comparison, that was more than Beaufort County's total budget for fiscal year 2017. The University's impact is significant despite the fact that state funding accounts for a small percentage of the University's annual budget. Similarly, to continue meeting the demands of USCB's growing student population, the state should provided capital support for the expansion of classroom and laboratory space and additional faculty office space needed on the Bluffton campus. Without the space required to educate additional students, it will be impossible for USCB to admit a sufficient number of students to fill the region's education gap.


Despite the strain of committing to expansion in order to meet the needs of its constituents, USCB will continue to support the region's more than 220-year commitment to affordable higher education. The Lowcountry of South Carolina shows no signs of curtailing its growth, and USCB will remain a key partner in the success of the region, the state, and the nation. While USCB is committed to diversifying its revenue sources and reducing overhead expenditures, additional appropriation and capital support
