Building on its 19th century origins as a distinctive women's college, the Winthrop University of the 21st century is achieving national stature as a competitive and distinctive, co-educational, public, residential comprehensive, values-oriented institution. The values of service, excellence, diversity, community, and leadership provide the foundation for Winthrop's continuing development and shape Winthrop's continuing success.

Winthrop enrolls an achievement-oriented, culturally diverse and socially responsible student body between 6,500 and 7,000 students. ## **REORGANIZATION AND COMPLIANCE**

Winthrop University offers quality and access while promoting individual achievement and the greater good, recognizing that higher education serves three primary, interrelated purposes:

- To fuel the economic engines of South Carolina and of the nation through workforce development and entrepreneurship;
- To prepare individuals for democratic citizenship and social responsibility through exposure to the liberal arts, diverse people and experiences, and challenges that develop higher levels of intellectual, ethical, and moral reasoning; and
- To promote professional success and social mobility by recognizing the fundamental connection between quality of education and equality of opportunity.

Winthrop University engages in continuous, institution-wide, research-based planning and evaluation that includes senior and mid-level leadership in academic, administrative, and student support service units. Winthrop's annual planning cycle is synchronized with South Carolina's Fiscal Year, July 1 through June 30.

Winthrop's 2020-21 State Accountability Report provides an overview of performance and achievements related to meeting institutional goals, complying with state and federal regulations, fulfilling regional accreditation standards (SACSCOC), and supporting South Carolina's Statewide Enterprise Strategic Objectives, specifically Objective #1 – Education, Training, and Human Development. Examples of the University's 2020-21 achievements span all campus divisions and are contextualized by the five goals of the Winthrop Plan, the institution's strategic plan.

**Goal 1: Support inclusive excellence by expanding our impact on students and our communities through enrollment growth and increases in retention and graduation rates.** (Supports South Carolina Statewide Enterprise Strategic *Objective #1 – Education, Training, and Human Development* and *Objective #4 – Public Infrastructure and Economic Development*.)

- Winthrop achieved its highest ever ranking in US News & World Report's 2021 edition of Best Colleges. The University moved from a ranking of 17<sup>th</sup> to 13<sup>th</sup> among regional universities in the South, rose from 8<sup>th</sup> to 7<sup>th</sup> place among best colleges for veterans; placed 12<sup>th</sup> for most innovative schools; and held at 11<sup>th</sup> place for best undergraduate teaching as judged by peers; and ranked 23<sup>rd</sup> for social mobility, a fairly new category that measures how well schools graduated students who received federal Pell Grants (those typically coming from households whose family incomes are less than \$50,000 annually).
- For the third-straight year, Winthrop was included in Money Magazine's, "Best Colleges for Your Money 2020." Educational quality is one of the three categories considered for inclusion in the value ratings.
- Winthrop's TriO Achievers Program was awarded \$1.375 million to help low-income, first generation and students with disabilities succeed in college. First funded in 2005, the program

has graduated 516, or 82% of overall students served. Additionally, 99% of TRiO Achievers Program participants are in good academic standing at the end of the year, 97% return for their second year; and more than three-fourths graduate within five years.

- The three-year average first-year student retention rate is 72%, with the 2014 cohort's six-year graduation rate 60.7%.
- Winthrop student athletes ranked 2<sup>nd</sup> highest in the Big South Conference for the percent of student athletes having a grade point average of 3.0 or higher. These student athletes additionally earned Presidential Honor Roll status.

**Goal 2: Continually enhance the quality of the Winthrop experience for all students by promoting a culture of innovation, with an emphasis on global and community engagement.** (Supports South Carolina Statewide Enterprise Strategic ***Objective #1 – Education, Training, and Human Development.***)

- Winthrop is once again named a Voter Friendly Campus. Winthrop is one of only four colleges in South Carolina to earn this designation. The Voter Friendly Campus initiative is led by the national nonpartisan organizations Fair Elections Center's Campus Vote Project (CVP) and NASPA – Student Affairs Administrators in Higher Education. The mission of the Voting Friendly designation is to bolster efforts that help students overcome barriers to participating in the political process.
- The Rock Hill School District recently recognized Winthrop's Jim and Sue Rex Institute for Educational Renewal with the 2020 Outstanding Partner Award for its assistance in helping a local elementary school with its lack of space. For many years The Rex Institute has worked with Rock Hill Schools in teacher preparation and professional development programs, awarding grants to teachers and schools to implement innovative and unique ideas, and providing on-going professional learning opportunities to area teachers and administrators.
- A grant from Family Trust expands Winthrop's Place for Hope Outreach Program. A Place for Hope (APFH) Eagles Program is aimed at helping Winthrop students build connections and offer resources to low-income communities. The service learning program provides afterschool programming including homework support, longer-term educational support, nutritious snacks, healthy recreation and cultural experiences.
- Winthrop's Small Business Development Center (SBDC) is on the front lines in helping local businesses navigate the COVID-19 pandemic. The SBDC has assisted small businesses with three primary programs: Payroll Protection Program (PPP), Economic Insurance Disaster Loan (EIDL) and Unemployment Insurance. The SBDC has also provided training on effective re-opening procedures and recovery basics.

**Goal 3: Attract and retain high quality and diverse faculty, staff, and administrators.** (Supports South Carolina Statewide Enterprise Strategic ***Objective #1 – Education, Training, and Human Development.***)

- Dr. Matthew Stern, Associate Professor of Biology, one of only 30 people out of more than 400 applicants, was named to the prestigious 2020-2023 class of the HHMI BioInteractive Ambassador Academy. The Academy provides professional learning experiences that promote and support evidence-based teaching practices; drive change in science education; and elevate the professional and scholarly profile of teaching science.
- Dr. Tenisha Powell, Associate Professor of Education, was the 2020 recipient of the Kevin J. Swick Excellence in Teacher Education Award from the South Carolina Association for the Education of Young Children. The award honors an educator who has made a significant contribution to the field of early childhood teacher education with the state of South Carolina.
- Dr. Takita Sumter, Dean of the College of Arts and Science and Professor of Chemistry, has been named as a Fellow of the American Society of Biochemistry and Molecular Biology. The Fellows designation recognizes the contributions of those members who have excelled in research, education, advocacy and mentorship of future scientists.
- Dr. Anthony Hill, Department Chair and Associate Professor of Social Work has been named Social Worker of the Year by the South Carolina Chapter of the National Association of Social Workers (SC-NASW).

**Goal 4: Provide facilities, technology, and programs that support Winthrop students and the overall Winthrop experience.** (Supports South Carolina Statewide Enterprise Strategic **Objective #4 – Public Infrastructure and Economic Development**.)

- Winthrop Board of Trustees approved \$21 million bond for upgrades to campus facilities. These upgrades include roof replacement, updating mechanical, electrical, plumbing and HVAC, and renovation to the University's main dining facility.
- The Winthrop Board of Trustees voted to leave in place the discounted fee structure for summer session 2021. At the onset of COVID-19, in recognition of the financial challenges facing students and their families, Winthrop approved a plan to discount tuition for all courses taken during the summer, including undergraduate, graduate and online graduate.
- Winthrop introduced three new undergraduate degree programs: Bachelor of Arts in Data Science; Bachelor of Science in Applied Software Development; and Bachelor in Educational Studies.

**Goal 5: Ensure financial stability and sustainability.** (Supports South Carolina Statewide Enterprise Strategic **Objective #1 – Education, Training, and Human Development**.)

- Winthrop receives \$1 million gift in honor of alumna and retired Estee Lauder Executive Ida Crawford Stewart. This gift will establish the Ida Crawford Stewart Endowment for the Arts, which will provide scholarships, faculty enrichment, program development, and discretionary funds related to the mission of the Winthrop's College of Visual and Performing Arts.

- A major gift donated by Winthrop University Board of Trustee, Gary Williams and his wife Peggy will establish the [Williams Family Multicultural Children’s Literacy Collaborative](#). The Collaborative will offer a variety of opportunities that promote literacy to pre K-12 students from York County’s diverse community.
- Interim President Dr. George W. Hynd in his [State of the University address](#), included information on future academic, budget and campus beauty initiatives. New budget modeling is in the works as the University will implement a new 3-5 year budget plan. The University launched a Campus Master Plan and campus beautification initiatives, and has begun laying the foundation for a future comprehensive fundraising campaign.

### **Risk Assessment and Mitigation Strategies**

A failure of Winthrop University to accomplish its mission and goals could **negatively impact the student educational experience and potentially weaken the pool of qualified candidates who support the workforce of the State of South Carolina**. Given that 90% of Winthrop undergraduates are from South Carolina and approximately 41% of Winthrop undergraduates are eligible for federal Pell grants, a diminished educational experience would negatively impact South Carolina’s historically underserved populations. These are the very citizens the State of South Carolina identifies as needing the most support to advance their education in order to compete for employment opportunities that provide a living wage.

**The University employs mitigating strategies** focused on enhancing operational efficiency, managing costs, sustaining effectiveness, emphasizing forward-thinking, and remaining current with education trends. These strategies are supported by the following efforts:

- The development (2015-16) and implementation (2016-17) of the [Winthrop Plan](#), which serves as a blueprint for the university through 2025, outlines the five goals and initiatives that Winthrop will achieve to **drive enrollment, retention, student success, diversity and fundraising** in order to become a **national model for a student-centered university experience**.
- Winthrop University remains compliant with standards of the institution’s regional accrediting body, the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC). In July 2017, [SACSCOC](#) approved the University’s Fifth-Year Interim Report and the Quality Enhancement Plan (QEP) Impact Report, with no request for additional reporting. Accreditation by SACSCOC signifies that the institution has a mission appropriate to higher education; has resources, programs, and services sufficient to accomplish and sustain its mission; maintains clearly specified educational objectives that are consistent with its mission and appropriate to the degrees offered; and assesses its achievement of stated objectives. The institution is currently developing the Compliance Certification Report and the QEP as requirements for the Decennial Review Class of 2022.
- Winthrop University retains [program-specific accreditation](#) with 22 accrediting bodies, thus ensuring the quality of its educational programs. The institution has traditionally sought and

received national accreditation for degree programs that maintain programmatic accreditation standards.

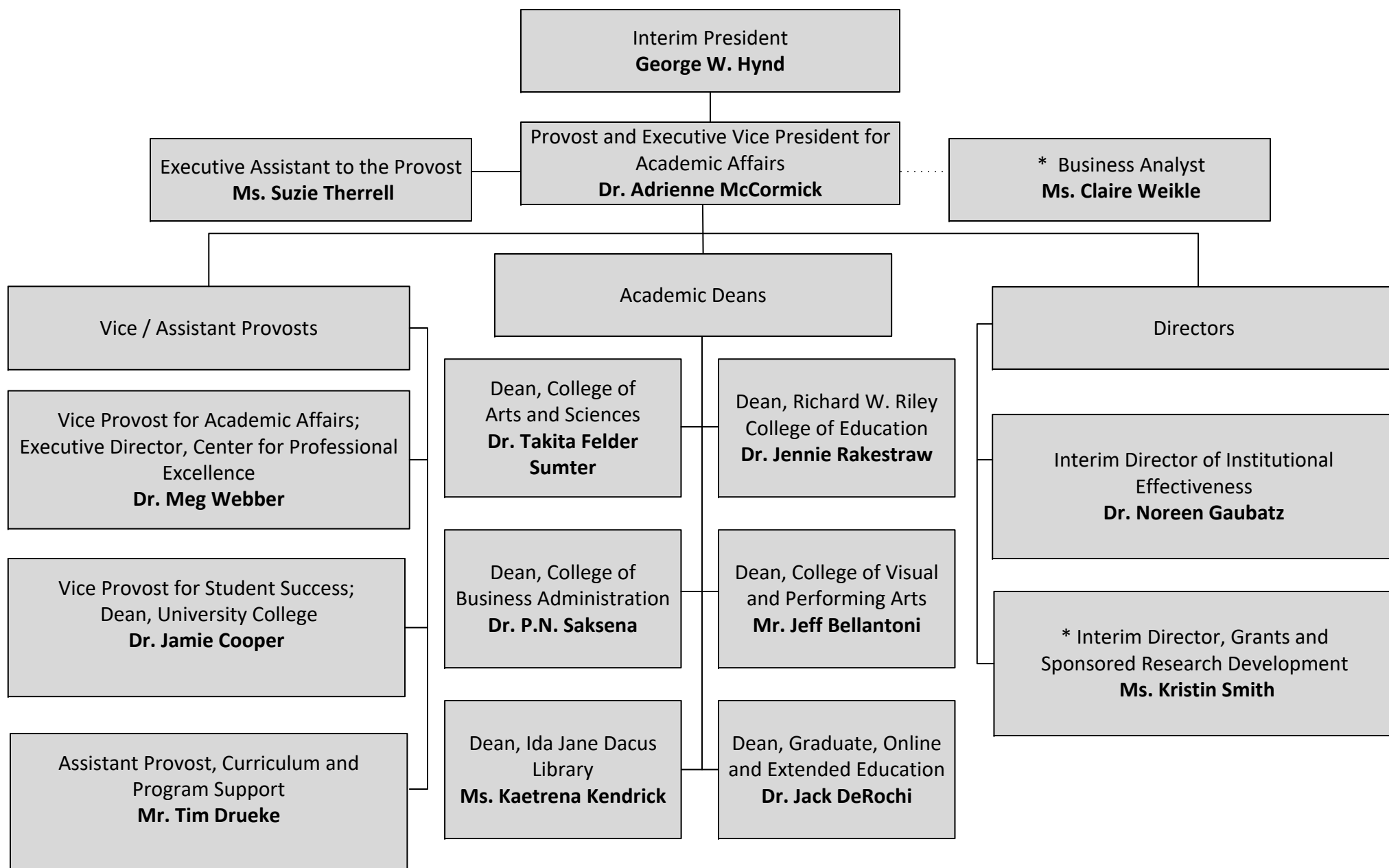
**Supportive actions by the State that could help to mitigate a** negative impact on the student educational experience include:

- Restore the proportion of state appropriations to Winthrop University to pre-2008 recession levels. This action would enable Winthrop to minimize fiscal impact upon students relative to tuition, fees, room, and board, thereby supporting Winthrop's goals to increase access, degree attainment, and inclusive excellence in learning experiences for all students.
- Fully fund salary increases for state employees. Cost of living increases that are mandated by the General Assembly, but not fully funded create significant challenges in balancing the institution's budget. The increased budgetary strain on the University has the potential to impact the quality of the student educational experience.
- Reduce institutional labor costs by eliminating reporting obligations that involve redundancy across state agencies.
