AGENCY'S DISCUSSION AND ANALYSIS

Physical Location and Description

University of South Carolina Lancaster (USCL) is a regional campus of the University of South Carolina (UofSC). USCL consists of three sites: The main campus, located in the City of Lancaster; the Native American Studies Center, located two miles south of the main campus in downtown Lancaster; and the Indian Land location, located 18 miles north of the main campus.

The USCL main campus consists of eight building. Founders Hall, Hubbard Hall, and the Bradley Arts and Sciences Building are designed for instruction. Besides standard classrooms, there are three large lecture halls, two auditoriums, five instructional computer labs, an art studio and gallery, five science laboratories, and a nursing simulation laboratory. These three instructional buildings also house most of the faculty offices. USCL holds public events in these buildings, such as theater performances, art gallery receptions, K-12 science fairs, and high school Honors Day. The Bradley Building houses the Palmetto College iCarolina Learning Lab, which opened in April 2022 and provides underserved communities with access to high-speed internet. The lab was funded by the Governor's Emergency Education Relief (GEER) fund. Hubbard Hall houses The Hubb, a satellite office of SC DHEC on the Lancaster campus. This is the first collaboration between SC DHEC and a college campus. The Hubb Coalition was a collaborative effort with local nonprofit organizations like the Arras Foundation, Upper Midlands Rural Health Network, and the Children's Council. SC DHEC clinicians staff the clinic and offer free and low-cost preventive healthcare designed for USCL students and to young people throughout the community. The Hubb Coalition partners work alongside TRIO staff to guide young people through an evidence-based program called Seventeen Days to negotiate condom use and ultimately prevent unintended pregnancies.

Medford Library is an academic library that is open to the public. The librarians provide access to physical and digital media, teach students to conduct research using library resources, and host library-related events. There are computers in the library that members of the Lancaster community can use, as well as a computer lab that can be reserved for instruction or used by USCL students to complete assignments. The Academic Success Center (ASC) is a free tutoring lab and writing center where USCL students develop their learning and writing skills. TRiO programs are federally funded programs designed to support students who face challenging circumstances. These include students who are first-generation college students, students with disabilities, and students from low-income households. Most USCL students qualify for TRiO services.

Starr Hall is dedicated to student services. These include the Financial Aid Office, the Business Office, and Disability Accommodations, as well as Student Life, the bookstore, vending, and the Student Center.

USCL's main campus is the home of Gregory Family YMCA. In addition to cardio and weight training equipment, the YMCA has handball, racquetball, volleyball and tennis courts, and an indoor swimming pool. The Carole Ray Dowling building contains an exercise science laboratory and a community room used for special events. The final building is dedicated to security and parking enforcement.

The Native American Studies Center (NASC), located downtown, is a top attraction in the Lancaster area. It consists of a large gallery, archaeological research spaces, and faculty offices. The gallery is open to the public. The NASC hosts a lunch-and-learn series that attracts tourists and locals alike to downtown Lancaster. NASC also hosts special events, like Native American Studies week and a Native American craft show during the City of Lancaster's annual Christmas festival.

In 2018, we began offering classes in the town of Indian Land, SC to accommodate the increase in demand for classes north of the main campus. Over the past year, USCL renovated a building at the former Indian Land High School location, in order to establish a permanent presence in Indian Land. This location opened in August, 2022 and consists of four classrooms, office space, restrooms, and storage.

Academic Profile

The website Niche.com ranks universities based on several key criteria including academics, cost, facilities, and faculty credentials. For the past five years USCL has been ranked the #1 community college in South Carolina and has remained in the 97th percentile of community colleges across the United States.

USCL offers four associate degrees: Associate of Arts, Associate of Sciences, Associate of Science in Business, and Associate of Science in Criminal Justice. Students can remain on the Lancaster campus to earn baccalaureate degrees through USCL's partnerships. USCL partners with the UofSC College of Nursing to offer a Bachelor of Science in Nursing (BSN) degree, which is ranked the #1 best RN program in South Carolina by RegisteredNursing.org. USCL is also a member of Palmetto College, a unit of UofSC. Palmetto College offers baccalaureate degree-completion programs online. Students who enroll in Palmetto College through USCL work towards a bachelor's degree in one of 24 majors while benefiting from student services available on the Lancaster campus. USCL also participates in Palmetto Pathways, a program that allows qualified USCL students to transition to UofSC's Columbia campus after one year.

Risk Assessment and Mitigation Strategies

USC Lancaster participates in the UofSC Enterprise Risk Management Program (ERM), which was established with the guidance of International Standards Organization, ensuring that any and all forms of risk are managed in a systematic, transparent, and credible manner. Risk is routinely considered in long- and short-term institutional planning. USCL is the primary higher education institute in the Lancaster area, and so failing to accomplish our goals and objectives would negatively impact the statewide enterprise objective to elevate the level of educational preparedness of South Carolinians.

USCL offers opportunities for a high-quality education at an affordable price. Therefore, failure to accomplish our goals would further disadvantage the least economically well-off citizens of our service area. Moreover, our Bachelor of Science in Nursing collaborative program is instrumental for offering high quality nursing care for our region by training nurses who stay in the region. Failure to accomplish our goals with this community would negatively impact the health and wellbeing of the service area. To mitigate such negative impacts our agency may require state funding to the general operating funds budget, increases in the amount allocated for dual enrollment tuition for high school students, and increases to state scholarship money available to students. Specifically, the General Assembly could help resolve potential issues in the following three ways:

- 1. Increase allocations to the general operating funds.
- 2. Increase the amount of revenue provided for dual credit students.
- 3. Increase state scholarship funds.

State Agency Strategic Plan and Measures

1.1. Attract and retain a highly qualified, appropriately sized, and diverse student body

As a state agency, USCL primarily works towards the statewide enterprise strategic objective of Education, Training, and Human Development. The objective states that we should strive to elevate the level of educational preparedness of South Carolinians. The first step we take towards this objective is to attract a student body that is representative of our service area. We schedule regular recruitment efforts throughout our service area and provide outstanding admissions and enrollment support to all students. One way we measure our success in recruitment is by counting the total number of applications for admission. In Fall 2021 we received 2428 applications. We also count the total number of students who register for classes. This is called the *headcount*. In Fall 2021, our headcount was 1729. The number of high school graduates in our service area has declined over the past couple of years, which may have caused our headcount and number of applicants to decrease. Although we didn't meet our ambitious targets, we believe our numbers provide strong evidence that we have been successful in attracting and enrolling students.

Our next step towards elevating the level of educational preparedness of South Carolinians is to retain registered students until they graduate or successfully transfer to a different university. The most recently calculated retention rate of first-time, full-time, degree-seeking freshmen reported by the SC Commission on Higher Education (CHE) is not from FY2021-2022. It shows the proportion of freshmen retained from Fall 2019 to Fall 2020. The rate was slightly lower than we expected: 46.6% rather than the expected 49%. In FY2021-2022 USCL awarded 135 associate degrees, meeting our target of 135 or more. SC CHE's most recently reported graduation rate of first-time, full-time, degree-seeking undergraduates is also for the 2017 cohort. It was 22.1%, meeting our goal of 20% or more. USCL uses the SC CHE definition of student success, which applies to 150% of program time: For associate degrees 150% of program time is 3 years; for bachelor's degrees it is 6 years. For each cohort of students, the success rate is calculated by counting the number of students who graduate or successfully transfer to

a different institution within 150% of program time, as well as those who remain at the same institution the fall after 150% of program time. The total is divided by the size of the cohort. Like the retention rate, the most recently calculated success rate reported by the SC CHE is not from FY2021-2022. It is for the 2017 cohort, for whom 150% of program time ended in 2020. USCL attained a 71% success rate, meeting our target of 66% or more.

1.2. Provide the highest quality of rigorous instruction and student-centric educational experiences to all students

One approach USCL takes to increasing retention is to maintain a low student-to-faculty ratio, thereby allowing students and faculty to have meaningful interactions. The National Center for Educational Statistics recommends a student-to-faculty ratio of 18-to-1 or less. In FY2021-2022, USCL's ratio was 16.8-to-1, meeting our goal. Beyond interacting with their instructors, USCL students also have access to the Academic Success Center (ASC). The ASC offers free tutoring from well-qualified staff as well as a Writing Center dedicated to developing students' writing skills. During FY2021-2022 the ASC held 507 tutoring session, meeting our goal of 357 or more. While the ASC is available to all students, TRiO programs are federally funded programs that support first-generation college students, students who come from low-income households, and students with disabilities. TRiO programs provide qualified students with academic support including tutoring and advisement. They also host community-building activities and events that allow students to support each other and support the Lancaster community. USCL students also have access to a wide range of support services, including disability accommodations and personal counselling.

2.1. Recruit and develop diverse faculty members who are excellent instructors and recognized scholars with a breadth of experience

We strive to offer our students a first-rate education, which means hiring and retaining first-rate faculty and staff. In Fall 2021, our faculty consisted of 50 full-time faculty members, along with two deans who teach part-time, and three retired faculty members who continue to teach full-time. During the fiscal year we celebrated the retirements of two faculty members. A new tenure-track faculty librarian began employment at USCL in Fall 2021. During FY2021-2022, USCL conducted six successful faculty searches for faculty who began employment during FY2022-2023.

The normal teaching load for each faculty member is equivalent to 12 credit hours per semester. This typically consists of four courses per semester but may vary slightly depending on the academic discipline. Faculty members who engage in scholarly research may request a workload reduction equivalent to a three-credit-hour reduction per year.

USCL encourages faculty to engage in professional development activities that enhance their teaching and research. These activities include off-campus opportunities through the UofSC Center for Teaching Excellence, as well as conferences and workshops hosted by academic societies. USCL also hosts oncampus professional development activities to support student success and retention. USCL recently

adopted Target X Retention software, which allows USCL faculty and staff to use a data-driven approach to improve student retention, success, and graduation rates. In FY2021-2022, eight faculty and staff were trained to use Target X. We intend to continue to train eight or more faculty and staff each year to use Target X or equivalent retention and success tools.

3.1. Promote research excellence and innovation

To promote research, USCL increased the combined budgets for professional travel and for the Research and Productive Scholarship (RPS) award program by \$5,000 to \$75,000. These programs support faculty research and travel to scholarly conferences. Six faculty members were awarded RPS awards in the areas of African American Studies, Biology, Philosophy, Physics, and Sociology.

Both students and the university benefit from a faculty member's scholarly research: the faculty member and the university gain recognition by outside professional organizations; the faculty member may be awarded external grants; and students experience cutting-edge advances in the faculty member's area of research. The UofSC Office of the Vice President for Research hosts the RISE grant program, a competitive program that funds faculty research and scholarly activities during the summer months. In FY2021-2022 four USCL faculty members were awarded RISE grants in the areas of Chemistry, Philosophy, Physics, and Theater. During FY2021-2022, USCL faculty disseminated their scholarship through 27 publications, 47 presentations, and 14 creative works. They were awarded 31 grants, mentored 14 undergraduate students in research, and participated in 196 other scholarly activities, including peer-review of scholarly work and professional consultations.

At USCL, faculty engage students in research within and beyond the classroom. Students are involved in scholarly organizations, such as the Chemistry Club and Research Club. They benefit from the PURE and Magellan undergraduate research grants, sponsored by the UofSC Office of Undergraduate Research. Students may earn one or both graduation honors: Graduation with Leadership Distinction (GLD) and the Undergraduate Research Award. During FY2021-2022, USCL held several series dedicated to cultivating undergraduate research. These activities can be organized into five categories.

- 1. Faculty presented their own research projects to a student audience.
- 2. Students presented their own faculty-guided research projects to a student audience.
- 3. Faculty and staff held workshops to support student research. These included teaching students to use research tools, best-practices in research, and guidelines for presenting research results.
- 4. Students who graduated with leadership distinction (GLD) presented their e-Portfolios.
- 5. Students presented their projects at the Discover UofSC research conference.

USCL also offers several courses focused on research. These classes underwent an evaluation process and were given the *GLD: Research* attribute. In FY2021-2022 USCL offered seven *GLD: Research* courses, meeting our goal of offering 6 or more. These courses were in the following subject areas: criminal justice, English, history, psychology, theater, and university-level research methods.

4.1. Create, promote, support and assess a campus culture/climate that embodies our Carolina Creed and makes every member of our university feel that they are valued and affirmed

USCL's Student Life hosted a variety of community-building events. There were many opportunities for students to network in a relaxed setting, including week-long events like Spring Fling, and single-day activities like bingo and food trucks. Some events were aimed at good citizenship. They raised awareness of and increased student involvement in social matters. These included domestic violence awareness and prevention, as well as blood drives and supplies drives. Campus-sponsored supply drives benefit local service organizations, K12 schools, USCL Food Pantry, and USCL students who need supplementary support. This year there was an additional supplies drive, organized by the USCL travel-study group. During their trip to Poland, the group of students and faculty delivered supplies to an organization supporting Ukrainian refugees. USCL also hosts a variety of events focused on US history and culture. These include a Constitution Day event, Native American Studies Week, and events for Black History Month, Hispanic Heritage Month, and Women's History Month.

The USCL Native American Studies Center (NASC) hosts a lunch-and-learn series, an artist-in-residence program, art gallery receptions, an archaeology lab, and craft shows that are open to the public. The NASC held four special events and series during FY2021-2022: The Brent Burgin Lunch-and-Learn series, Native American Studies Week, Traditional Catawba Online Art Series, and presentations by Artist-in-Residence Alex Osborn. In total, NASC hosted 5317 visitors, including USCL students and members of the public, meeting our goal of 1592 or more visitors.

USCL offers courses with the attributes *GLD*: *Diversity and Social Advocacy*, and *GLD*: *Global Learning*. As with the *GLD*: *Research* courses, these courses underwent a review process to earn these attributes. In FY2021-2022, USCL offered fifteen courses with these attributes, meeting our goal of offering eight or more. These included classes in anthropology, art history, criminal justice, English, history, public health, sociology, and women/gender studies.

USCL's Diversity, Equity, and Inclusion (DEI) committee led two cohorts of faculty and staff in studying issues related to DEI, meeting our target of two or more cohorts per year. The first cohort used the book *Teaching to Transgress* by bell hooks to guide the cohort in examining ways of engaging diversity, equity, inclusion, and access in the classroom and thinking about how faculty and staff take care of themselves and their students. The second cohort read the book *What the Best College Students Do* by Ken Bain, a text focused on the student, offering insight into the ways faculty and staff can nurture and support students' success at USCL and beyond.

USCL students participate in the arts and athletics. During FY2021-2022, nine USCL theater students earned awards in ten categories through the South Carolina Speech and Theater College Festival. USCL is a member of the National Junior College Athletic Association (NJCAA). We have four NJCAA athletic teams: baseball, men's soccer, women's soccer, and women's volleyball. In FY2021-2022, Our men's soccer team finished first in the region, while the women's team finished second. Our volleyball made

it to the post-season and finished fourth. Our baseball team competed in the Region X tournament. One student from the women's soccer team earned Honorable Mention as Region X All-American. Two other soccer players made Region X All-Region Third Team. Twenty baseball players made the Region X Academic All-Region, an honor for student athletes with a GPA of 3.0 or higher.

5.1. Leverage the university system to provide accelerated, lower cost multi-degree options for students

Although USCL is primarily a two-year college, our students can earn baccalaureate degrees through our partnerships with UofSC College of Nursing and Palmetto College. In FY2021-2022, the Bachelor of Science in Nursing (BSN) program, offered through the College of Nursing, met their goal of enrolling 46 or more students in the upper-level program. Lancaster students can enroll in any one of 24 degree-completion programs through Palmetto College. Two of these degrees, the Bachelor of Liberal Studies (BLS) and the Bachelor of Organizational Leadership (BOL), are accredited through Palmetto College. The remaining 22 degrees are accredited through other UofSC campuses. In Fall 2021, eighty-nine Lancaster students were enrolled in the BLS and BOL programs. USCL also participates in Palmetto Pathways, a program that allows qualified USCL students to transition to UofSC's Columbia campus after one year. In Fall 2021, 90 students enrolled in Palmetto Pathways, meeting our goal of 90 or more.

6.1. Expand community partnerships to create business opportunities, develop new relationships, and increase experiential learning

To aid in student success in a job or career, USCL hosts two career-oriented lecture series: Careers in Science and Careers in Business. These series allow current students to make connections with people working in their chosen career.

USCL also offers many courses with the attributes of *Experiential Learning*, *GLD: Internship*, *GLD: Community Service*, and *GLD: Professional and Civic Engagement*. These courses underwent an evaluation process in order to earn their attributes. In FY2021-2022 we met our goal of offering 18 or more courses with these attributes. We offered 23 courses in the subject areas of anthropology, criminal justice, educational psychology, English, public health, information technology, management, internships, service-learning, leadership, philosophy, psychology, sociology, social work, speech, integrative learning, and women/gender studies.

USCL also provides support services for students pursuing employment. USCL's Career Services offers career coaching, help in writing resumes, and mock interviews. USCL's Internship Director adopted Handshake, a database that provides access to internships and jobs. In FY2021-2022, four students were accepted to internship positions through this tool. In this year USCL extended the use of Handshake to USCL alumni.

7.1 Provide a physical campus that supports the academic and student life needs of the modern and future university while ensuring safety of the university community


Besides education, USCL also contributes to the statewide enterprise objective of Public Infrastructure and Economic Development. The objective states, in part, that we should build a world-class and safe public infrastructure to enhance the quality of life of our citizens. One way we achieve this goal is to strengthen the campus' financial condition. We measure this in two ways. The first is to consider the USCL reserve-fund carry-forward amount. Our target is to increase this reserve so that we maintain an amount equal to or greater than three months of our operating cost. During FY2021-2022 USCL increased the reserve fund by 35% to \$5,080,674.00, meeting our target of \$4,084,574.00 or more. Another measure we use is the expenses-to-budget ratio. This shows the relative size of the total expenses incurred compared to the total budget resources. A small ratio is desirable. In FY2021-2022 our expenses-to-budget ratio was 90%, meeting our goal of 97.4% or less.

USCL also strives to make education more affordable. One strategy is to increase the number of endowed scholarship funds held by the Educational Foundation of USC Lancaster. In FY2021-2022 the Educational Foundation had 167 endowed scholarship funds, meeting our target of 159 or more funds. USCL also participated in four major fundraising events that benefitted the USCL Educational Foundation: Big Thursday, Give Local Lancaster, Give 4 Garnet, and an ongoing commemorative brick fundraiser.

Summary

University of South Carolina Lancaster is vital to the education of South Carolinians in our service area. We provide accessible and affordable higher education led by staff and faculty who are experts in their fields. Beyond the classroom, we strive to develop the whole person through co-curricular and extracurricular activities. As an institution and as individuals, we work to enhance our community socially and economically. It is clear that members of our service area value our work: our enrollments are stable, and our finances are growing. We're recognized by external reviewers as the #1 ranked community college in South Carolina, one of the top community colleges in the United States, and, in partnership with UofSC, providers of the #1 ranked RN program in South Carolina.

The Lancaster regional Palmetto College campus is a branch campus of the University of South Carolina Columbia. Lancaster has as its mission to provide higher education and intellectual leadership to its service area. At the heart of this mission is a teaching faculty of high quality dedicated to excellence in instruction, scholarship, public and professional service, and creative endeavor which enrich the classroom experience. The Lancaster regional Palmetto College campus offers a varied curriculum grounded in the liberal arts and focused on preparing students to continue their education in the University of South Carolina System and throughout life.

The Lancaster regional Palmetto College campus recruits students prepared to succeed in completing a baccalaureate-level education. While the institution does not offer remedial instruction, it is nonetheless able to admit most students who apply due to the close working relationship between students and faculty. The Lancaster regional Palmetto College campus was established to encourage higher education in the counties of Chester, Chesterfield, Fairfield, Kershaw, Lancaster, and York. The original design of the institution incorporated a flexibility that has allowed changes in institutional capability with increasing educational demands of constituents.

Through classroom and laboratory instruction delivered in a variety of face-to-face and distance learning formats and modalities, the institution awards the Associate in Arts and Associate in Science degrees and provides for the completion of selected bachelor's degrees on campus through cooperative agreements and delivery structures with other University of South Carolina System institutions. The Lancaster regional Palmetto College campus also provides general education and upper division coursework applicable to baccalaureate degree programs offered through colleges and universities nationwide. In addition to academic coursework, the mission of the campus includes noncredit courses, seminars, and workshops made available to the community for cultural enrichment and professional development.

The traditions of cultural diversity and freedom of thought are valued at the Lancaster regional Palmetto College campus. In a learning environment that develops respect for racial, geographical, intellectual, and economic diversity and an awareness of individual, societal, and global responsibilities, Lancaster promotes courses, activities, and attitudes which influence the life of the mind in men and women and instills in them a thirst to continue learning throughout life.

The Lancaster regional Palmetto College campus emphasizes the development of the whole person and especially seeks to foster in students the disciplines essential to an educated citizenry. Core competencies, including the ability to communicate through effective writing and articulate speech; computational and quantitative mastery; creative and critical thinking; and the duties of citizenship are strategically integrated within the curriculum. Classroom experiences, student activities, and physical education programs also provide opportunities for cultural enrichment, leadership development, intellectual growth and interpersonal relationships, all contributing to a sense of self-reliance and a joy of learning.

USC Lancaster seeks to continuously enhance its intellectual environment and expand access to its academic programs.
