AGENCY'S DISCUSSION AND ANALYSIS

STATEWIDE ENTERPRISE STRATEGIC OBJECTIVES

The University has explicitly integrated three statewide enterprise strategic objectives into its own strategic and tactical planning, operations, management, and assessment.

- Education, Training and Human Development: the University endeavors, as its primary mission, to elevate the educational preparedness of South Carolinians to lead productive and healthy lives. An important component of this is ensuring that our students have pathways for success in their professional careers and in their communities as thought leaders and citizens.
- Public Infrastructure and Economic Development: the University continues to build a world-class infrastructure of knowledge, wisdom, creativity, and physical and human resources to serve South Carolina's citizens and to promote South Carolina as a globally competitive location for business, innovation, and living.
- Healthy and Safe Families: the University contributes to the health, development, and safety of South
 Carolina families in myriad ways including: food security through research, educational programming, and
 supporting cooperative extension; developing talented personnel and research-proven programs to improve
 the effectiveness of PK-12 education; and supporting personal and public health via research programs and
 practitioner education.

CLEMSON FORWARD: A S.M.A.R.T PLAN

The statewide enterprise objectives and its S.M.A.R.T. (Specific, Measurable, Attainable, and Time-bound) framework for objectives were integrated components of our Clemson FORWARD strategic plan, which had four principal parts—each of which had quantitative targets to be achieved over a 10-year time frame:

Research: Solving REAL Problems

- Promote a culture of discovery by raising research expectations and rewards for excellence.
- Invest in six core areas to address 21st century challenges: advanced materials; cyber infrastructure and big data science; energy, transportation, and advanced manufacturing; health innovation; human resilience; and the sustainable environment.
- Increase sponsored program award proposals and sponsored program research expenditures.
- Increase scholarly publication and citation measurement.

Engagement: Providing REAL Experience

- Nurture, enhance, and expand evidence-based academic engagement.
- Build a campus-wide global engagement infrastructure.
- Enhance engagement opportunities outside the classroom.

Academic Core: Sustaining REAL Quality

- Revise our General Education curriculum.
- Enhance integrated interdisciplinary education through a new Grand Challenge minors program.
- Increase the number of high-quality, nationally prominent graduate programs.
- Professionalize academic advising.
- Increase graduation and retention rates of undergraduate students.

Living: Building REAL Family

- Build a climate that attracts and retains a more diverse student body, faculty, and staff.
- Lead the nation in professional quality of life and in compensation programs that recognize and reward performance.

Robust internal tracking and inclusion of many of these metrics into the State Accountability Report monitors and shares our progress towards, and holds us accountable for, specific, measurable targets associated with Clemson FORWARD. These metrics comprise the Performance Measures in the Strategic Planning Results component of the University's Agency Accountability Report.

UNIVERSITY PERFORMANCE

Accountability Report Strategic Planning Measures

FY23 saw continued very high achievement in the undergraduate student success performance measures in the accompanying Strategic Planning component of this report. Freshman retention dipped a percentage point from its historic high to a still-enviable 92.4%. Our 6-year and 4-year graduation rates were flat, and remained near historic levels at 85.3% and 68.30%—far exceeding the mean values of national public universities. The 4-year rate remained robustly above our 63.9% target.

During FY22, the University continued to surpass its ambitious 2026 goal of \$100M in research expenditures. The fiscal year's expenditure total stood at \$160.3M, a \$20M increase from FY22 and far surpassing this year's \$91M target value that was set several years ago as part of the University's strategic plan.

The FY23 values for the portion of the undergraduate student body that are underrepresented minorities (16.1%) and non-majority (23.0%) once again stood at new historically high levels. These measures of the socioeconomic reach of our primary services both exceeded this fiscal year's target values. The proportion of our graduate student body comprising underrepresented minorities increased by 10 basis points from last year to 12.3%, but fell below the FY23 target value by 90 basis points.

The number of underrepresented minority faculty increased from 111 to 116 in FY23, and fell short of this year's target (153) established as part of the University's strategic plan. The University extended its participation in a federally-funded grant initiative aimed at recruiting, developing, mentoring, and retaining underrepresented faculty members. Additionally, the University continues its development of new business processes and management tools to inform and track the level of diversity in its faculty candidate pools.

Scholarly productivity (as measured by per faculty journal articles) increased by 6% in FY23 over FY22 levels, meeting the target value. The University has provided more of its college deans, associate deans, and department chairs with analytical tools that enable them to benchmark the scholarly productivity in their departments and academic doctoral programs over time and against national peers. FY23 saw a significant expansion in the capability and breadth of these tools. The University continued its relaunch of data tools to identify scholarly collaborators within the University and nationally, find or have pushed to them (via text/e-mail) potential grant funding opportunities at an individual faculty member level, and identify honorific award nomination opportunities.

External grant funding requests continued rising in FY23 compared to FY22, finishing the fiscal year at \$932.8M—well above the ambitious \$848M FY23 target set as part of the University's former strategic plan. While we continue to monitor this measure as part of our new strategic plan, its strategic importance has diminished from our initial judgment as the success rate of our funding requests has significantly exceeded expectations.

ClemsonFORWARD Support Initiatives

There are several foundational elements that support and serve as accelerators for Clemson FORWARD. These include: a strategic operational focus; a commitment to accountability in serving as a prudent steward of resources; strategic and entrepreneurial revenue growth; and unwavering attention to academic success. These same elements are expected to continue serving as a critical tactical foundation to our new Clemson Elevate strategic plan (see below). Notable progress with these foundational elements was made during the past fiscal year. Examples include:

- The University processed the termination of numerous low-demand academic programs and low-activity centers and institutes, continuing data-driven analysis of our program portfolio initiated 5 years ago to identify those components to be considered for closure and termination.
- We continued to develop and implement a limited number of select entrepreneurial revenue-generating master's, graduate certificate, and two ground-breaking baccalaureate degree (automotive engineering and data science) programs aligned with high-demand workforce needs.
- Multi-year implementation of a new ERP system, providing enchanced services and integration between fiscal and HR systems and services, began.
- Multi-year planning continued regarding a new decentralized responsibility-based budgeting model.
- The University began planning for the State's first College of Veterinary Medicine, which we hope will see its first class of matriculating students in Fall 2026.
- The University submitted its compliance certification report for its 10-year accreditation reaffirmation review by its accreditor, the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC); submitted a follow-up Focused Report and Quality Enhancement plan to SACSCOC; and hosted site visits by SACSCOC visiting teams on its main campus, and at multiple instructional sites in Charleston and Greenville. The SACSCOC Review Committee had no recommendations or findings in response to these reports and visits. As a result, we wholly anticipate a 10-year reaffirmation of Clemson's accreditation at the SACSCOC Board meeting in December 2023.
- The University secured a partnership with a premier online learning platform to provide distance education delivery of select strategic graduate programs at a global scale.

Clemson Elevate: A New Strategic Plan

In April 2023, the University unveiled its new strategic plan, Clemson Elevate, that will commence in earnest in FY2024. The plan comprises three strategic pillars:

- Deliver the No. 1 Student Experience- Excel in experiential learning, amplify academic success, and promote the Clemson Experience.
- Double Research by 2035- Build an AAU-aligned faculty to address societal needs, create world-class research infrastructure, and leverage Innovation Campuses and partnerships.

• Transform Lives Statewide and Beyond- Enhance educational and economic opportunities; improve agriculture, natural resources, and animal health; and improve health outcomes for South Carolinians.

Clemson Elevate also explicitly recognizes several areas of excellence that represent current strengths, future opportunities, high ROI, interdisciplinary in nature, or doctoral education-focused. These include: AI/data science/cybersecurity, human performance, ecosystems/digital water, energy transformation and advanced manufacturing, food systems and environmental resilience, the future of learning and work, precision medicine/human genomics, rural health initiatives, neuroscience to neuroengineering, emerging infectious diseases, advanced materials, a College of Veterinary Medicine, and clinical facilities/care transformation.

Building Futures:

Building state-of-the-art facilities, renovating aging structures, and creating multi-functional spaces that support a vibrant academic community are critical to the success of the new Clemson Elevate strategic plan. Significant activities in enhancing our physical infrastructure during FY23 included:

- A June 20, 2023 groundbreaking for the \$155 million Bryan Mall residence hall renovation project to support the "No. 1 Student Experience" pillar of our strategic plan. Built in 1967, 1968, and 1970 (respectively), Mannining Hall, lever Hall, and Byrnes Hall house some 1400 students each year. The project includes upgrade and replacement of these residence hall's mechanical, electrical and plumbing systems; movement of entrances to face each other and create a community courtyard; provision of social space on every floor; and replacement of community bathrooms with home-like private bath spaces.
- A May 16, 2023 groundbreaking for the \$130 million Advanced Materials Innovation Complex (AMIC), a
 143,000 square foot facility designed for education and research scheduled to open at the end of 2025. This
 facility heralds a new era of innovation and workforce development in advanced materials for South
 Carolina and the broader region. AMIC will the University's most technologically advanced facility; it will
 include cutting-edge research and teaching laboratories, synergistic classrooms, and collaborative spaces for
 exploration and conversation outside the lab and classroom. AMIC will also be the new home of the
 Department of Materials Science and Engineering.
- A February 1, 2023 groundbreaking for a new approximately 100,000 square foot Alumni and Visitors Center
 that will be home to some of the University's most crucial partners and programs, including the Clemson
 Alumni Association, Class of 1944 Visitors Center, the Board of Trustees office, Advancement, Clemson
 University Goundation, Admissions, and the Michelin Career Center. The new Alumni and Visitors Center
 will overlook the 18th green of the John E. Walker Sr. Golf Course and the shores of Lake Hartwell, standing
 as the University's front door—inviting prospective students to explore campus and welcoming past
 generations back home.
- Many Clemson students attending classes in the FY23 year did so in a brand-new facility at the heart of campus: Humanities Hall. This 52,633 square foot facility is part of the larger Daniel Hall Renovation and Expansion, which is geared toward meeting the needs of the University's growing student body. In addition to 12 new classrooms ranging in size from 18 to 72 seats. The building also boasts a 250-seat lecture hall, a debate lab, four offices, two conference rooms, and eight "collaboration spaces" where students can study and congregate between classes. Humanities Hall is also the new home of the Pearce Center for Professional Communication, which offers undergraduate client-based internships, professional development for graduate teaching assistants, and faculty writing workshops.
- Continuation of a major facelift to the heart of Clemson's campus—specifically the workhorse Daniel Hall building. This renovation will enhance accessibility, update and improve HVAC and fire protection systems, upgrade Daniel Hall's existing auditorium, and replace exterior doors.

- The Clemson University Board of Trustees gave Phase II approval for \$16,000,000 to establish the project budget to demolish Johnstone Hall/Core Campus comprising the 132,500 square foot Johnstone Hall (built in the 1950's as temporary housing and well past its useful life), the Union Building Complex (constructed in 1974 and in poor condition), as well as smaller facilities associated with University Facilities' move away from the campus core. Demolition will support the University's broader strategy to prioritize on-campus space for student-centric needs.
- The Clemson University Board of Trustees approved a change of funding source for the Women's Sports Program Expansion. This project provides for the construction of new facilities for women's athletics programs, including gymnastics and lacrosse, adjacent to the existing women's rowing facility. The project will provide a new women's gymnastics training facility of approximately 21,000 square feet; a new women's lacrosse operations facility of approximately 9,000 square feet and an artificial turf field with stadium seating; and an operations facility comprising coaches' offices, a locker room, student-athlete lounge, film room, and a sports medicine room. A 10,000 square feet addition between the existing rowing center and boathouse will serve as a Women's Elite Athlete Recover Center comprising space for sports medicine, strength and conditioning, physical therapy, and nutrition areas. These facilities are expected to support 135 female student-athletes. The revised funding source mix removes \$10 million of Athletic Facility Revenue Bonds and funds the entire project using \$37 million in cash funds from Gifts.
- The Clemson University Board of Trustees gave Phase 2 approval for a new chiller plant. New campus buildings being planned will exceed available cooling system production and distribution capabilities by 2026 and the aging Central Energy Facility will be phased out over the next ten years. For energy cooling production facilities to remain efficient and in good condition and to keep pace with Clemson's projected growth in research and enrollment, this project increases chiller capacity on a per square foot basis by 30% via rejuvenating and expanding three existing chilled water plants with underground utility distribution piping upgrades, replacing aging centrifugal chiller capacity, and adding capacity for future campus buildings and chiller plant building space.
- The Clemson University Board of Trustees gave Phase 2 approval to the renovation of Tillman Auditorium. The project includes repositioning of space, inclusion of more natural lighting, new seating, new HVAC and lighting, and infrastructure upgrades. The auditorium and its parent building has not been renovated in some 42 years. After removal of the large stage for theatrical productions that is no longer needed, additional seating will be added to the 13,165 square foot auditorium, which will become the largest teaching venue on campus.

University Fundraising

The University had another extraordinary record-breaking fundraising year—our seventh consecutive year eclipsing \$150 million, and twelfth consecutive year eclipsing \$100 million. Private gifts to Clemson University totaled \$216.9 million this fiscal year, and included: more than \$147 million in cash, pledges, and gifts in kind; \$21 million in planned gifts; 24 gifts of \$1 million or more; unrestricted donations of over \$4 million; and \$135 million for IPTAY in support of our nearly 500 Clemson student-athletes. Particularly notable is that the FY23 fundraising level represents a continuing increased level in philanthropic giving eight years following the close of our Will to Lead capital campaign, as our donors and supporters continue to engage with our students, faculty, and staff to support the Clemson Experience.

In total, 37,857 members of the Clemson University community adapted to the challenges of the past three years and showed their support with 101,674 total gifts. These gifts will support initiatives that include 129 new scholarships/fellowships and the creation of 87 new endowments. FY2023 saw our eighth-annual Give Day (4/5/23) produce \$1.9 million from 4,182 donors. FY23 saw an enviably high 17.2% alumni participation rate.

The gifts received make it possible for Clemson to provide the student support, academic resources, and facilities that are commensurate with its standing as one of the finest public universities in the country.

Building on the FY18 launch of the Cornerstone Partners for Academics program, modeled after the successful Cornerstone Partners for Athletics program, FY23 saw three new critical Academic Cornerstone gifts this year. These included:

- A transformational \$10 million gift from Mark and Kathryn Richardson to support scholarships for Clemson students, the Wilbur O. and Ann Powers College of Business, projects and programs within the college of Education that strengthen teacher retention, and several University programs that increase access to education: Emerging Scholars, Call Me MiSTER, and ClemsonLIFE.
- A \$2.5 million gift from Charles, Susan, and Lexie Barker to establish the Charlie, Suzie, and Lexie Barker '20 Presidential Scholarship Endowment, support the ClemsonLIFE program, and become the first pillar donor in support of the construction of the Samuel J. Cadden Chapel.

FY23 saw the establishment of an additional 2 new Athletic Cornerstone partnerships. In conjunction with the IPTAY gifts, these contributions from our loyal donors are directly promoting our student-athletes through robust facilities, scholarships, academic support services, strength and conditioning, life skills, nutrition services, and more.

University Athletics

During FY23, Clemson Athletics continued to create life-changing experiences for student-athletes, fans, and families. FY23 saw recording-breaking athletic achievements, ACC championships in four sports (football, women's golf, men's outdoor track and field, and baseball), eight NCAA appearances, the inaugural competing season of women's lacrosse, an indoor NCAA championship in hurdles by Giano Roberts, and Valerie Cagle making history as the second woman from Clemson Univerity to win the National Player of the Year Award in any sport.

It was also a record-breaking year for fundraising in which over \$132 million were received in total commitments for the first time in IPTAY history. This includes the largest single gift in IPTAY history, more than \$40 million in annual funds, 100% of premium seats sold, and a record 22,040 IPTAY members.

Academically, Clemson student-athletes had a record GPA average of 3.25 in the spring 2023 semester to add onto a 3.23 in the fall, and 374 students were named to the ACC academic honor roll (varsity-level student-athletes with a GPA of 3.0 or higher) shattering last year's record of 337 students.

During the NCAA's most recent data release, it was announced that eight Clemson programs either set or tied records for Academic Progress Rate (APR), which is a multi-year rate measured both overall and for individual teams. These records include six perfect 1,000 multi-year scores and 11 single-year scores at 1,000. The six programs that scored perfectly were Women's and Men's Golf, Softball, Women's Tennis, Women's track, and Men's cross country while Men's soccer and Men's track set records for their programs.

The department matched a record with a 95% Graduation Success Rate (GSR) for the 2012-15 cohort in data released by the NCAA. It was the ninth consecutive cohort in which Clemson's department-wide GSR was at 91 percent or higher, and second in a row at 95 percent; we are one of only four public Power Five schools to make that claim. Nine Clemson programs set or tied program records for GSR.

In February, three Clemson Tigers were awarded Weaver-James-Corrigan-Swofford Postgraduate Scholarships. These recipients were Hal Hershfelt (Women's soccer), Mckenna Slavik (volleyball), and KJ Henry (football). These postgraduate awards are given to selected students who intend to pursue a graduate degree and will receive \$6,000 towards their graduate degree. Recipients are individuals who have excelled in the classroom, in their respective sports, and in the community.

Three Tiger teams went on foreign tours and had opportunities to compete, bond, and explore overseas while representing Clemson University. The men's soccer team went on a foreign tour to Italy in May 2023 and visited Romen, Genova, and Milan. The women's volleyball team went visited France, Croatia, and Bosnia in early June of 2023. In August of 2023, the women's basketball team traveled to Greece and Croatia.

Major award winners included Cagle, a National Player of the Year, while Kelley Hester and Mark Elliott were each named ACC Coach of the Year after winning league titles.

In terms of facilities, Clemson debuted its new football videoboard, lights, and sound as part of Phase I renovations at Memorial Stadium. The department also broke ground on a \$37M women's sports expansion project to house the lacrosse and gymnastics programs adjacent to Lake Hartwell. Construction is expected to be completed in late 2023.

RISK ASSESSMENT AND MITIGATION STRATEGIES

The potential most negative impact on the public as a result of a failure in accomplishing our mission is the risk of socioeconomic retrenchment arising from diminishment of workforce development for key state enterprises: fewer qualified human resources and knowledge discovery that support critical needs such as health and education; impairment of research that is required for thriving advanced manufacturing, health, financial, educational, and agricultural enterprises; reduction in the effectiveness of good government that comes from an educated public; hindrance of efforts to close educational gaps between populations undergoing demographic changes; and erosion of the cultural resources and climate that support South Carolinians' important community, personal, and spiritual relationships.

Clemson works diligently and collaboratively to mitigate such risks. Examples of these efforts include:

- 1) Compliance with the standards of our accrediting body, SACSCOC, through effectiveness in day-to-day business operations
- 2) Collaboration and compliance with professional academic bodies to maintain program-specific accreditation of numerous academic programs at the University.
- 3) Transparent dealings with private-sector credit rating agencies who conduct independent business and financial reviews to reach their independent conclusions regarding our creditworthiness.
- 4) Nurturing authentic relationships with corporations, private foundations, and individuals to understand their needs, establish mutually beneficial programmatic initiatives, and engender private financial support.
- 5) Securing select private-sector services to ensure that we have data resources with which to reach conscious, evidence-based decisions regarding our academic programs, scholarly production, operations, and student welfare initiatives.

6) A vigorous enterprise risk management and business continuity framework that provides us with a proactive posture to continue successful operations in the face of sudden or unforeseen events such as COVID19.


Supportive actions by the State that would mitigate the risk of the potential most negative impact would be those that provide flexibility and innovation space to Clemson for the benefit of its students, their families, and South Carolinians. Examples of these might include:

- 1) Eliminating or loosening State-imposed percentage-of-tuition-based caps on institutional scholarship aid—particularly need-based aid.
- 2) Employing a ramped or stepped reduction in student-directed State scholarship aid rather than a sharp cutoff when falling below GPA thresholds, and/or restorative scholarship payments when GPA thresholds are re-attained.
- 3) The University, its students, their families, and the State benefit greatly from direct State appropriations and State scholarship funds provided to students. As Clemson works to help SC prepare to meet future challenges, we do so on a competitive landscape. Inasmuch as our current private endowment is modest compared to many public university competitors, securing State educational appropriations per student FTE that is at the median level of our competitive peers according to the SHEEO (see Figure 2.3 of the FY22 SHEF report) is important while we continue our successful work at developing greater and more diverse sources of long-term private support.


