Department of Labor, Licensing and Regulation. The bill requires the Board of Medical Examiners to develop a "Start Talking!" consent form and provides guidelines for the

information presented on the form and that must be completed by a parent of the minor. The department reports that any expenditure associated with the development of this form will be absorbed within the agency's Other Funds appropriated budget. This bill would have no expenditure impact on the General Fund or Federal Funds.
