### **Fiscal Impact Summary**

This bill will have no impact on the General Fund, Federal Funds, or Other Funds, because the Department of Health and Environmental Control (DHEC) and the Office of Attorney General will administer policies resulting from the bill with the use of existing staff and resources. This fiscal impact statement has been updated based on a response from DHEC.

# **Explanation of Fiscal Impact**

# Updated for additional agency response Introduced January 23, 2018 State Expenditure

This bill establishes a Solid Waste Emergency Fund. This new fund will be created by the transfer of funds from the existing Solid Waste Management Trust Fund. The Solid Waste Management Trust Fund is funded by the collection of fees for the sale of motor oil, tires, lead acid batteries, and white goods. Two and one-half percent of the funds remitted each quarter to the Solid Waste Management Trust Fund will be transferred to the Solid Waste Emergency Fund. The unencumbered balance of the Solid Waste Emergency Fund shall equal \$1,500,000. When expenditures occur, DHEC will transfer funds in the same manner until the balance is restored.

This bill also requires all unpermitted facilities that recycle construction and demolition debris to register with and obtain a permit from DHEC.

**Department of Health and Environmental Control.** This bill creates the Solid Waste Emergency Fund, which will be administered by DHEC. The department will be responsible for investigating waste management sites for the purpose of addressing emergency situations. This bill authorizes the department, along with the Office of Attorney General, to take actions to recover costs incurred due to willful disregard for the provisions of this bill.

This bill requires permits for facilities that recycle construction and demolition debris, and provides for certain exemptions from this requirement.

DHEC reports that the activities required pursuant to this bill will be performed by existing staff. Therefore, this bill will have no expenditure impact on the General Fund, Federal Funds, or Other Funds. This fiscal impact statement has been updated based on a response from DHEC.
