

Capital Reserve Fund – Draft Bill

A JOINT RESOLUTION TO APPROPRIATE MONIES FROM THE CAPITAL RESERVE FUND FOR FISCAL YEAR 2019-2020.

Be it enacted by the General Assembly of the State of South Carolina:

SECTION 1. In accordance with the provisions of Section 36(B)(2) and (3), Article III, Constitution of South Carolina, 1895, and Section 11-11-320(C) and (D) of the 1976 Code, there is appropriated from the monies available in the Capital Reserve Fund for Fiscal Year 2019-2020 the following amounts for Maintenance and Care of State-Owned Assets:

Regulation of expenditure of appropriations for Maintenance and Care of State-Owned Assets

SECTION 2. Funds appropriated in Section 1 shall be expended for the purposes of maintenance, repair, or renovation of existing state-owned facilities. Institutions shall be prohibited from using funds appropriated in Section 1 for any new construction or real property acquisitions.

Posting of Appropriations

SECTION 3. The Comptroller General shall post the appropriations contained in this joint resolution as provided in Section 11-11-320(D) of the 1976 Code. Unexpended funds appropriated pursuant to this joint resolution may be carried forward to succeeding fiscal years and expended for the same purposes.

Time effective

SECTION 4. This joint resolution takes effect thirty days after the completion of the 2019-2020 Fiscal Year in accordance with the provisions of Section 36(B)(3)(a), Article III, Constitution of South Carolina, 1895, and Section 11-11-320(D)(1) of the 1976 Code.
