## **Fiscal Impact Summary**

This joint resolution requires the Department of Health and Environmental Control (DHEC) to promulgate regulations that establish maximum contaminant levels (MCLs) for likely or known carcinogens and toxic chemicals that are likely to pose a substantial health hazard in public water systems. The expenditure impact on DHEC is undetermined as the agency is unable to estimate the impact of establishing MCLs for certain carcinogens and toxic chemicals in public water systems.

This fiscal impact statement has been updated to include a response from DHEC.

## **Explanation of Fiscal Impact**

#### Updated for Additional Agency Response on February 13, 2023 Introduced on January 10, 2023 State Expenditure

This joint resolution requires DHEC to promulgate regulations, within 180 days of the effective date of the resolution, that establish MCLs for likely or known carcinogens and toxic chemicals that are likely to pose a substantial health hazard in public water systems. DHEC must also annually review the latest peer-reviewed science and independent or governmental agency studies and promulgate, if necessary, additional or revised regulations. The expenditure impact on DHEC is undetermined as the agency is unable to estimate the impact of establishing MCLs for certain carcinogens and toxic chemicals in public water systems.
