## **Fiscal Impact Summary**

The bill specifies that a certified nurse aid in a hospital may start and cap peripheral intravenous lines and conduct patient blood draws as authorized by an approved written protocol or set of guidelines. The bill further defines a certified nurse aid as a person who successfully completes required training, passes the National Nurse Aid Assessment Program and is registered in good standing with the South Carolina Nurse Aide Registry of the South Carolina Department of Health and Human Services (DHHS).

This bill will have no expenditure impact on the Department of Labor, Licensing and Regulation (LLR) or the South Carolina Board of Nursing since the Board of Nursing does not regulate certified nursing assistants.

This bill is not expected to have an expenditure impact on DHHS since it does not alter the responsibilities of the agency. DHHS will continue to license certified nurse aides in the same manner. Additionally, Medicaid payments will not be impacted by this bill.
