Fiscal Impact Summary

This bill permits mobile optometry units to operate during the summer at a site of an organization serving children from low-income communities if approved by the local community foundation serving the region. The bill further specifies that a licensed optometrist who is providing services through a mobile unit is not subject to disciplinary action on the sole basis that the licensed optometrist prescribed eyeglasses without dilating the patient's eyes at the aforementioned site.

The Department of Labor, Licensing and Regulation, (LLR) does not anticipate that this bill will have an expenditure impact on the agency or the Board of Examiners in Optometry since the bill does not alter the responsibilities of the agency or the board. LLR further indicates that any expenses to implement the bill can be managed within existing resources.

This bill may result in an increase in optometry services for Medicaid by making it easier for students to obtain care. While the amount of the increase for the Medicaid program is undetermined, the Department of Health and Human Services (DHHS) does not anticipate a significant impact to the program. DHHS anticipates that any increase in expenditures can be managed within existing appropriations.
