### SOUTH CAROLINA STATE REGISTER

An official state publication, the *South Carolina State Register* is a temporary update to South Carolina's official compilation of agency regulations—the *South Carolina Code of Regulations*. Changes in regulations, whether by adoption, amendment, repeal, or emergency action must be published in the *State Register* pursuant to the provisions of the Administrative Procedures Act. The *State Register* also publishes the Governor's Executive Orders, notices of public hearings and meetings, and other documents issued by state agencies considered to be in the public interest. All documents published in the *State Register* are drafted by state agencies and are published as submitted. Publication of any material in the *State Register* is the official notice of such information.

#### STYLE AND FORMAT

Documents are arranged within each issue of the *State Register* according to the type of document filed:

**Pending Regulations Submitted to the General Assembly** are regulations adopted by the agency pending approval by the General Assembly.

**Executive Orders** are actions issued and taken by the Governor.

**Notices** are documents considered by the agency to have general public interest.

**Notices of Drafting Regulations** give interested persons the opportunity to comment during the initial drafting period before regulations are submitted as a proposed regulation.

**Proposed Regulations** are those regulations pending permanent adoption by an agency.

**Final Regulations** have been permanently adopted by the agency and approved by the General Assembly.

**Emergency Regulations** have been adopted on an emergency basis by the agency.

#### **2026 Publication Schedule**

Documents will be accepted for filing on any normal business day from 8:30 A.M. until 5:00 P.M. All documents must be submitted in the format prescribed in the *Standards Manual for Drafting and Filing Regulations*.

To be included for publication in the next issue of the *State Register*, documents must be submitted no later than 5:00 P.M. on the second Friday of each month. The modification or withdrawal of documents filed for publication must be made by 5:00 P.M. on the submission deadline for that issue.

#### REPRODUCING OFFICIAL DOCUMENTS

Documents appearing in the *State Register* are prepared and printed at public expense. Media services are encouraged to give wide publicity to documents printed in the *State Register*.

#### **PUBLIC INSPECTION OF DOCUMENTS**

Documents filed with the Office of the State Register are available for public inspection during normal office hours, 8:30 A.M. to 5:00 P.M., Monday through Friday. The Office of the State Register is in the Legislative Council, Fourth Floor, Rembert C. Dennis Building, 1000 Assembly Street, in Columbia. Telephone inquiries concerning material in the *State Register* or the *South Carolina Code of Regulations* may be made by calling (803) 212-4500.

#### ADOPTION, AMENDMENT AND REPEAL OF REGULATIONS

To adopt, amend, or repeal a regulation, an agency must publish in the *State Register* a Notice of Drafting and a Notice of the Proposed Regulation that contains an estimate of the proposed action's economic impact and gives the public an opportunity to comment on the proposal. If requested by twenty-five persons, a public hearing must be held at least thirty days after the date of publication of the notice in the *State Register*.

After the date of hearing, the regulation must be submitted to the General Assembly for approval. The General Assembly has one-hundred-ten days to consider the regulation. If no legislation is introduced to disapprove or enacted to approve the regulation before the expiration of the one-hundred-ten-day review period, the regulation is approved on the one-hundred-tenth day and is effective upon publication in the *State Register*.

#### **EMERGENCY REGULATIONS**

An emergency regulation may be promulgated by an agency if the agency finds imminent peril to public health, safety, or welfare. Emergency regulations are effective upon filing for a ninety-day period. If the original filing began and expired during the legislative interim, the regulation can be renewed once.

#### REGULATIONS PROMULGATED TO COMPLY WITH FEDERAL LAW

Regulations promulgated to comply with federal laws are exempt from General Assembly review. Following the notice of proposed regulation and hearing, regulations are submitted to the *State Register* and are effective upon publication.

#### EFFECTIVE DATE OF REGULATIONS

**Final Regulations** take effect on the date of publication in the *State Register* unless otherwise noted within the text of the regulation.

**Emergency Regulations** take effect upon filing with the Legislative Council and remain effective for ninety days. If the original ninety-day period begins and expires during the legislative interim, the regulation may be refiled for one additional ninety-day period.

#### Executive Order No. 2025-40

- WHEREAS, racial discrimination is wrong, and "[d]istinctions between citizens solely because of their ancestry are by their very nature odious to a free people whose institutions are founded upon the doctrine of equality." Students for Fair Admissions, Inc. v. President & Fellows of Harvard Coll., 600 U.S. 181, 208 (2023); and
- WHEREAS, nowhere in South Carolina law should there be provisions that discriminate on the basis of race; and
- **WHEREAS**, several sections of the South Carolina Code of Laws, as amended, call for unlawful racial discrimination in state procurement and contract decisions; and
- WHEREAS, Chapter 35, Article 21 of Title 11 of the South Carolina Code, as amended, titled "Assistance to Minority Businesses," makes race a central feature of procurement policy ("Title 11 Race-Based Procurement Policy"); and
- WHEREAS, the Title 11 Race-Based Procurement Policy calls for selectively favoring "Minority Business Enterprises" (MBEs) in the procurement process; and
- WHEREAS, Regulation 19-445.2160 creates a race-based distinction by defining a "Minority Business Enterprise" as "a business which has been certified as a socially and economically disadvantaged small business" and defines "social disadvantaged individuals" as people who have "been subject to racial or ethnic prejudice or cultural bias because of their identification as members of a certain group without regard to their individual qualities." S.C. Code Ann. Regs. 19-445.2160(A)(2), (6); and
- WHEREAS, the law incentivizes racial discrimination by providing that "[f]irms with state contracts that subcontract with minority firms shall be eligible for an income tax credit equal to four percent of the payments to minority subcontractors for work pursuant to a state contract," subject to certain limitations, S.C. Code Ann. § 11-35-5230(B); see also id. § 12-6-3350; and
- WHEREAS, the Title 11 Race-Based Procurement Policy requires "each agency director [to] develop a Minority Business Enterprise (MBE) Utilization Plan," which must include, among other things, "a policy statement expressing a commitment by the governmental body to use MBEs in all aspects of procurement" and a "goal[]" of spending "ten percent of [that] governmental body's total dollar amount of funds expended" on minority businesses. *Id.* § 11-35-5240(1); and
- WHEREAS, an agency's MBE Utilization Plan must be submitted annually to the Division of Small and Minority Business Contracting and Certification, and an agency must submit quarterly progress reports to the Division. *Id.* § 11-35-5240(1); *see also id.* § 11-35-5270 (revised by 2014 S.C. Acts No. 121 to transfer responsibility from the Small and Minority Business Assistance Office to the Division); and
- WHEREAS, the Title 11 Race-Based Procurement Policy requires an annual report to the Governor "concerning the number and dollar value of contracts awarded for each governmental body to a firm certified as a minority firm pursuant to Section 11-35-5230 during the preceding fiscal year." *Id.* § 11-35-5260; and
- WHEREAS, at least one other provision of South Carolina law poses similar problems of racial discrimination in contracting. Section 12-28-2930 of the South Carolina Code of Laws, as amended, requires the South Carolina Department of Transportation to "ensure that not less than five percent" of state source highway funds be "expended through direct contracts with certain estimated values . . . with small business concerns owned and controlled by socially and economically disadvantaged ethnic minorities (MBEs)" ("Title 12 Race-Based Procurement Policy"); and

#### **4 EXECUTIVE ORDERS**

- **WHEREAS**, the "core purpose" of the Fourteenth Amendment's Equal Protection Clause is "doing away with all governmentally imposed discrimination based on race" "[b]ecause racial discrimination is invidious in all contexts," *Students for Fair Admissions*, 600 U.S. at 206, 214 (internal quotation marks and alterations omitted); and
- **WHEREAS**, both the Title 11 Race-Based Procurement Policy and the Title 12 Race-Based Procurement Policy represent governmentally imposed discrimination based on race by favoring some races at the expense of others; and
- WHEREAS, these polices rest on the false assumption that the solution to perceived historical wrongs is to racially discriminate against individuals in the present; and
- **WHEREAS**, "[t]he way to stop discrimination on the basis of race is to stop discriminating on the basis of race," *Parents Involved in Cmty. Sch. v. Seattle Sch. Dist. No. 1*, 551 U.S. 701, 748 (2007); and
- **WHEREAS**, the Supreme Court of the United States has held that race-based programs "must comply with strict scrutiny, they may never use race as a stereotype or negative, and—at some point—they must end." *Students for Fair Admissions*, 600 U.S. at 213; and
- WHEREAS, the Title 11 Race-Based Procurement Policy and the Title 12 Race-Based Procurement Policy meet none of these constitutional requirements to permit racial discrimination. See City of Richmond v. J.A. Croson Co., 488 U.S. 469 (1989) (striking down a 30% set aside in government contracting for MBEs); Mid-Am. Milling Co., LLC v. U.S. Dep't of Transp., No. 3:23-CV-00072-GFVT, 2024 WL 4267183, at \*1 (E.D. Ky. Sept. 23, 2024) (granting a preliminary injunction against the federal government's "Disadvantaged Enterprise Program" that "require[s] that ten percent of federal highway construction funds be paid to small businesses owned and controlled by 'socially and economically disadvantaged individuals'"); Students for Fair Admissions, 600 U.S. at 218–19 (holding that "zero-sum" policies, such as the State awarding contracts, necessarily treat race as a "negative"); id. at 213 (explaining that a race-based law lacks a logical end point where it has "no end . . . in sight"); and
- **WHEREAS**, the United States Constitution "shall be the supreme Law of the Land," U.S. Const. art. VI, cl. 2, so when state law conflicts with any federal law, "the state law must yield." *Martin v. United States*, 605 U.S. 395, 409 (2025); and
- WHEREAS, the undersigned has sworn to "preserve, protect, and defend" both the South Carolina Constitution and the United States Constitution, S.C. Const. art. VI, § 5, and is charged with "tak[ing] care that the laws be faithfully executed," *id.* art. IV, § 15; and
- **WHEREAS**, the Title 11 Race-Based Procurement Policy and the Title 12 Race-Based Procurement Policy are incompatible with the Fourteenth Amendment's Equal Protection Clause; and
- **WHEREAS**, these laws "also undermine our national unity, as they deny, discredit, and undermine the traditional American values of hard work, excellence, and individual achievement in favor of an unlawful, corrosive, and pernicious identity-based spoils system." President Donald J. Trump, Executive Order 14173, § 2, Ending Illegal Discrimination and Restoring Merit-Based Opportunity (Jan. 21, 2025); and
- **WHEREAS**, hardworking South Carolinians "who deserve a shot at the American Dream should not be stigmatized, demeaned, or shut out of opportunities because of their race." *Id.*; and
- WHEREAS, the federal government, under the leadership of President Donald J. Trump, is similarly working to "terminate all discriminatory and illegal preferences, mandates, policies, programs, activities, guidance, regulations, enforcement actions, consent orders, and requirements." *Id.*; and

**WHEREAS**, the undersigned has the constitutional and statutory authority to demand information from state agencies. *See* S.C. Const. art. IV, § 17; S.C. Code Ann. § 1-1-840; *id.* § 1-3-10.

**NOW, THEREFORE**, by virtue of the authority vested in me as Governor of the State of South Carolina and pursuant to the Constitution and Laws of this State and the powers conferred upon me therein, I hereby order and direct as follows:

### Section 1. Eliminating Unlawful Racial Discrimination in State Procurement and Contract Decisions

- A. I hereby direct all departments, agencies, and other offices in the Executive Branch to comply with the Equal Protection Clause by not discriminating based on race in any procurement or contract matter.
- B. I hereby direct, until any statutory change requires otherwise, that when departments, agencies, and other offices in the Executive Branch report to the Division of Small and Minority Business Contracting and Certification as required by Section 11-35-5260 of the South Carolina Code of Laws, as amended, the report shall certify that the department, agency, or other office is complying with the Equal Protection Clause and this Executive Order in all procurement and contract decisions.
- C. I hereby direct all departments, agencies, and other offices in the Executive Branch to provide to the Office of the Governor by January 9, 2026, information about any regulation, policy, or practice that requires or permits the department, agency, or other office to consider race in any procurement or contract decision, regardless of whether that regulation, policy, or practice is connected to the Title 11 Race-Based Procurement Policy or the Title 12 Race-Based Procurement Policy.
- D. No department, agency, or other office in the Executive Branch shall enter into any contract under either the Title 11 Race-Based Procurement Policy or the Title 12 Race-Based Procurement Policy until further order or instruction from the undersigned.
- E. This Executive Order is prospective only. No department, agency, or other office in the Executive Branch shall breach any existing contract under this Executive Order.

#### **Section 2. General Provisions**

- A. This Order is not intended to create, and does not create, any individual right, privilege, or benefit, whether substantive or procedural, enforceable at law or in equity by any party against the State of South Carolina, its agencies, departments, political subdivisions, or other entities, or any officers, employees, or agents thereof, or any other person.
- B. If any section, subsection, paragraph, subparagraph, sentence, clause, phrase, or word of this Order is for any reason held to be unconstitutional or invalid, such holding shall not affect the constitutionality or validity of the remaining portions of this Order, as the undersigned would have issued this Order, and each and every section, subsection, paragraph, subparagraph, sentence, clause, phrase, and word thereof, irrespective of the fact that any one or more other sections, subsections, paragraphs, subparagraphs, sentences, clauses, phrases, or words hereof may be declared to be unconstitutional, invalid, or otherwise ineffective.
- C. This Order shall be implemented consistent with and to the maximum extent provided by applicable law and shall be subject to the availability of appropriations. This Order shall not be interpreted, applied, implemented, or construed in a manner so as to impair, impede, or otherwise affect the authority granted by law to an executive agency or department, or the officials or head thereof, including the undersigned.
- D. I hereby expressly authorize the Office of the Governor to provide or issue any necessary and appropriate additional or supplemental guidance, rules, regulations, or restrictions regarding the application of

this Order or to otherwise provide clarification regarding the same, through appropriate means, without the need for further Orders.

CHAPTER 63

Statutory Authority: 1976 Code Section 57-3-110

#### **Notice of Drafting:**

The South Carolina Department of Transportation is considering repealing or amending existing regulations which govern, to the extent authorized by S. C. Code, Title 57, regulations concerning driveways, erosion control, tandem trailer combinations, disadvantaged business enterprise program, guidelines for selection of set aside projects, and bus shelters permitting.

Interested parties should submit written comments to Barbara M. Wessinger, Chief Counsel, South Carolina Department of Transportation, 955 Park Street, Columbia, S. C. 29202.

#### **Synopsis:**

The South Carolina Department of Transportation proposes to repeal Chapter 63, Article 4, Subarticle 5 entitled "Private Driveway Entrances to Highways". This regulation was promulgated in 1983. The residential driveway provisions are already codified in Section 57-5-1140 (including widths and culvert-cost responsibilities), and SCDOT's exclusive authority under Section 57-3-110 is implemented through the ARMS manual and Engineering Directives, which govern driveway design and the encroachment-permit process.

The South Carolina Department of Transportation proposes to repeal Chapter 63, Article 4, Subarticle 6 entitled "Erosion Control". This regulation has been replaced by Regulations 72-405 through 72-445 standards for Stormwater Management and Sediment Reduction, 1976 Code Section 48-18-70(4).

The South Carolina Department of Transportation proposes to amend Chapter 63, Article 4, Subarticle 7 entitled "Tandem Trailer Combination and Other Larger Vehicle Access Control Act". This subarticle sets forth the regulations governing the operation of tandem trailer combination and other large vehicles within the State. In consultation with SC State Transport Police (STP), a Law Enforcement Division of South Carolina Department of Public Safety, STP has confirmed that they do not currently use these regulations. The South Carolina Department of Transportation proposes to retain Regulation 63-390 and strike the remaining provisions.

The South Carolina Department of Transportation proposes to repeal Chapter 63, Article 8 entitled "Disadvantaged Business Enterprises Program". This article was promulgated to carry out the disadvantaged business enterprise program mandated by Section 12-28-2930 of the Code of Laws (1976) as amended, (hereinafter "State DBE Program") and to comply with 49 CFR Park 26 (hereinafter Federal DBE Program). The program requires participation by ethnic minority and female/women owned businesses. The federal program requires removal of minority and sex-based certification. The department, as recipient of federal-aid highway and transit funds, is required and intends to implement DBE Program in accordance with 49 CFR part 26 criteria.

The South Carolina Department of Transportation proposes to repeal Chapter 63, Article 9 entitled "Bus Shelters". This Article was intended to regulate the placement of bus shelters, with commercial advertisement, on state right of way.

These regulations will not require legislative action.

Statutory Authority: 1976 Code Section 59-112-100

62-600 - 62-612. Determination of Rates of Tuition and Fees.

#### Preamble:

R.62-600 through 62-612 of Chapter 62 is being amended and replaced in its entirety. Revisions to the existing regulation for the SC Residency Regulation are being considered to clarify the policies and procedures for administering the program. In the proposed amendments, the regulation is being updated to reflect recently passed Act 51 of 2023, relating to the requirement to acquire a South Carolina Driver's license within a 45 day period of relocating to the state. In addition, the number of items required to show intent are being reduced. There are other revisions which seek to simplify the residency process for both applicants and institutions. The revisions seek to promote flexibility among the State institutions and their residency classification processes.

The proposed regulation will require legislative review.

A Notice of Drafting was published in the South Carolina State Register on June 27, 2025.

number of days to acquire a S.C. Driver's License reduced to 45 days in order to be consistent with state law. Number of vehicles required to be registered for residency purposes reduced to one.

D. Language removed to provide greater flexibility to institutions and applicants when attempting to prove intent to be a S.C. resident.

Section 62-609: A(2). Language added to allow Faculty and Administrative Employees at public colleges to qualify for twelve month exception to residency.

A(3). Language to clarify how an individual working remotely for a company that has a S.C. location may qualify for twelve month exception to residency, based on full-time employment.

Section 62-611: A. Language removed to clarify that institutions may not prevent students from obtaining transcripts in the event they owe the institution funds.

Section 62-612: B. Language removed to provide institutions flexibility in the appeal process for residency.

**CHAPTER 27** 

Statutory Authority: 1976 Code Section 47-4-30

27-1011. Diseases and Health Documentation.

#### **Emergency Situation:**

Clemson University Livestock-Poultry Health (CULPH) officials are closely monitoring a multi-state outbreak of Equine Herpes Virus (EHV-1) and its neurologic form, Equine Herpes Myeloencephalopathy (EHM), linked to barrel racing and rodeo-type events that occurred in Waco, Texas, and a follow-up event in Oklahoma. More than 1,800 horses attended the two events, with at least 27 EHM cases confirmed at the Women's Professional Rodeo Association World Championship Barrel Racing in Waco, Texas. There is a case of EHM reported in Maryland that is not associated with the Waco, Texas, outbreak.

EHV-1 is a highly contagious virus in horses and other equids. While EHV-1 most commonly causes respiratory disease, some strains cause outbreaks of EHM. Classic clinical signs of EHM include fever, swelling/stocking up of the limbs, hindlimb weakness, and urine dribbling. Some horses are more severely affected and display behavior changes, signs of cranial nerve dysfunction, seizures, and the inability to stand. While EHM is a serious disease, the majority of cases are not fatal. In most outbreaks of EHM, 60-70% of affected horses recover with treatment and supportive care.

To help prevent and protect South Carolina horses from being exposed to this strain of EHV-1, CULPH proposes to heighten awareness of the disease outbreak for increased vigilance and temporarily update equid movement safeguards.

#### Text:

#### REPORTABLE DISEASE IN SOUTH CAROLINA BY CLINICAL SYMPTOMS

Sore Mouth-Muzzle: especially if accompanied by foot, udder, vulva or skin lesions (Blisters-Vesicles)

Ex: Foot & Mouth, Vesicular Stomatitis, etc.

Encephalitis (CNS) Conditions in All Animals and Birds.

Ex: Eastern, Western and Venezuelan Equine Encephalomyelitis, West Nile Encephalitis

Pseudorabies, Bovine Spongioform Encephalopathy—BSE

Caprine Arthritis Encephalitis

High Death Loss —especially over a short period and in older animals past several weeks old.

Ex: Hog Cholera, Erysipelas, Anthrax, Acute Septicemias

Reproductive Problems

Ex: Brucellosis, Pseudorabies, Contagious Equine Metritis (CEM)

Any Highly Unusual Condition —Disease or parasites differing from conditions one is familiar with.

Ex: All foreign and exotic diseases and parasites, unusual symptomatology of any kind.

- B. Certificate of Veterinary Inspection (CVI)-In addition to the statutory requirements, each CVI shall list all applicable permit numbers, the date of issuance thereof, the name of the issuing agency and the farm or other location from whence the livestock/poultry originated.
- 1. All equines entering South Carolina must be traveling on a CVI signed by a licensed and accredited veterinarian.
- a. Equines that may have been exposed to EHV-1 or EHM within 21 days prior to the CVI inspection are not eligible for importation into South Carolina.
- <u>b. Equines exhibiting any clinical signs consistent with EHV-1 or EHM are not eligible for importation</u> into South Carolina.
- c. The accredited and licensed veterinarian must include the following statement on the CVI completing the examination and confirm 1.a. and 1.b.: "The equine(s) listed on the CVI have not originated from a premises currently quarantined or exposed to EHV-1 in the last 21 days."
- 2. The Extended Equine Certificates of Veterinary Inspection (EECVI) are suspended for importing equids into South Carolina until further notice.
- 3. For exporting horses from South Carolina to other states, participants in the program must check with other states for their requirements related to the movement of equids across state lines and their CVI requirements.
  - 4. All other importation requirements for equids eligible for entry into South Carolina remain in place.
- C. Health Permits (HP)-The State Veterinarian may authorize the issuance of HPs, under such terms and conditions as he deems appropriate. HPs shall not be employed as substitutes or in lieu of CVIs, but shall be

issued as temporary measures only in emergency situations or under circumstances which could not have been reasonably foreseen. HPs shall expire no more than 30 days after issue and may not be renewed.

D. Appropriate Test(s)-A requirement for a negative test for a particular disease or condition may be satisfied by a negative result from any test approved by the USDA for detection of the particular disease or condition, unless otherwise indicated.

#### Statement of Need and Reasonableness:

The proposed temporary addition of rational equid movement restrictions will help prevent the introduction of the virus into South Carolina, protecting the equid population.

#### DESCRIPTION OF REGULATION:

The emergency regulation changes impacting equine movement in South Carolina and the requisite veterinary inspection certificates for such equine movement covers:

- 1. All equines entering South Carolina must be traveling on a CVI signed by a licensed and accredited veterinarian.
- a. Equines that may have been exposed to EHV-1 or EHM within 21 days prior to the CVI inspection are not eligible for importation into South Carolina.
- b. Equines exhibiting any clinical signs consistent with EHV-1 or EHM are not eligible for importation into South Carolina.
- c. The accredited and licensed veterinarian must include the following statement on the CVI completing the examination and confirm 1.a. and 1.b.: "The equine(s) listed on the CVI have not originated from a premises currently quarantined or exposed to EHV-1 in the last 21 days."
- 2. The Extended Equine Certificates of Veterinary Inspection (EECVI) are suspended for importing equids into South Carolina until further notice.
- 3. For exporting horses from South Carolina to other states, participants in the program must check with other states for their requirements related to the movement of equids across state lines and their CVI requirements.
  - 4. All other importation requirements for equids eligible for entry into South Carolina remain in place.

Plan for Implementation: LPH program staff will implement and enforce the described procedures immediately upon passage. Outreach and education efforts working with equid owners, exhibition leadership, and event organizers about risk analysis and biosecurity have already ensued and will continue. Additionally, any person, business, or entity regularly engaged in the possible movement of equid may contact LPH staff for guidance.

The costs associated with restricting movement to CVIs approved and signed by accredited and licensed veterinarians is minimized by this already being a requirement for most equid movements. Requiring a veterinary statement attesting to the animals not exhibiting clinical disease and or having exposure is an additional safeguard to help prevent the virus currently associated with the EHM outbreak entering South Carolina. The 21 days listed in the veterinarian statement covers the incubation period of the virus and when clinical signs should have shown.

The Extended Equine Certificate of Veterinary Inspection (EECVI) is a program accepted in some states where eligible owners who show, exhibit, sell, or participate in many events during a six-month period can create a CVI without a veterinary signature. During disease outbreaks, this increases the risk of spreading disease into unaffected states. There will be additional fees for these owners by temporarily suspending this program, but suspending the program will help decrease the risk of the disease spread.

#### **UNCERTAINTIES OF ESTIMATES:**

Great efforts have gone into predicting and mitigating unnecessary financial impacts to the aforementioned. Costs are already required to move animals interstate, and efforts were made to minimize those costs while mitigating the risk of disease spread and provide as little negative impact to the equid industry as possible, while providing good preventative measures/practices related to protecting equid health and disease spread across the state. The costs associated with treating an outbreak in South Carolina would exceed the costs of mitigation.

#### EFFECT ON ENVIRONMENT AND PUBLIC HEALTH:

This is an animal health disease that only affects equids.

DETRIMENTAL EFFECT ON THE ENVIRONMENT AND PUBLIC HEALTH IF THE REGULATION IS NOT IMPLEMENTED:

Without implementation of the proposed temporary regulations, the risk of the EHV-1 strain causing EHM entering South Carolina increases, which increases the risk of intra and interstate spread of the disease by not taking appropriate measures to prevent.

#### **Statement of Rationale:**

The temporary addition of rational equid movement restrictions will help prevent the introduction of the virus into South Carolina, protecting the equid population.

# Document No. 5410 CLEMSON UNIVERSITY STATE LIVESTOCK-POULTRY HEALTH COMMISSION CHAPTER 27

Statutory Authority: 1976 Code Sections 47-4-30 and 47-17-130

27-1023. State Meat Inspection Regulation.

#### **Synopsis:**

These regulations are being promulgated to modernize, clarify and update existing regulations which govern, to the extent authorized by S. C. Code, Title 47, Chapter 4, the inspection of meat and meat food products produced for intrastate commerce. These updated regulations are necessary to comply with the Federal Meat Inspection Act (21 USCA 661, Section 301) which established Federal-State Cooperative Meat Inspection Programs. This is a grant program where federal funds for any year shall not exceed 50 per centum of the estimated total cost of the cooperative program. A cooperating state is required to adopt regulations at least as stringent as those adopted by the United States Government. This regulation will, in effect, adopt the current Federal Meat Inspection Regulations with some minor exceptions for some state specific requirements.

The Notice of Drafting was published in the State Register on August 22, 2025.

#### **Instructions:**

Print the regulation as shown below. All other items remain unchanged.

#### Text:

27-1023. State Meat Inspection Regulation.

#### A. Definitions.

- 1. Commission means the State Livestock-Poultry Health Commission, Clemson University.
- 2. Director means the Director, Livestock-Poultry Health Programs, Clemson University.
- 3. Custom Processor means the custom preparation by any person of carcasses, parts thereof, meat or meat food products derived from the slaughter by any individual of cattle, sheep, swine or goats of his own raising or from game animals, delivered by the owner thereof for such custom preparation and transportation in commerce of such custom prepared article, exclusively for the use in the household by the owner and members of the owners household and the owners non-paying guests and employees in an establishment permitted by the State Meat Inspection Department for that purpose.
  - B. Permit required; fee; application; refusal, revocation or suspension.
    - 1. Custom processors shall secure a permit from the Commission.
- 2. The permit fee is twenty-five dollars (\$25.00) annually or for part of a year. The permit year is July 1 to June 30. The fee must be retained by the Commission. The Commission by regulation may increase the fee to not more than fifty dollars (\$50.00).
- 3. The Commission, for cause, may refuse to grant a permit, may revoke or modify a permit, or assess a civil penalty in accordance with Section 47-4-130, South Carolina Code of Laws (1976) as amended.

#### C. Adoption of Federal Meat Inspection Regulations.

The United States Department of Agriculture, Food Safety and Inspection Service, Meat Inspection Regulations, 9 CFR, Chapter III, Subchapter A, Parts 300-321, 325, 329, 332, 335, 352 and 354, and Subchapter E, Parts 412, 416-418, 424, 430, 441, 442 and 500 and all changes thereto in effect as of January 1, 2026, are hereby adopted as the State Meat Inspection Regulations, with exceptions as noted below.

#### 18 FINAL REGULATIONS

- D. Exceptions to the Federal Meat Inspection Regulations.
- 1. Subchapter A, Part 307, Section 307.5(a) Overtime Inspection Service. Fees and charges for overtime inspection service will be established, as required, by the Commission.
- 2. Subchapter A, Part 307, Section 307.5(b) Holiday Inspection Service. State holidays as designated by the State Budget and Control Board will be utilized by the state inspection program.
- 3. Subchapter A, Part 312 Official Marks, Devices and Certificates. Official state marks, devices and certificates of inspection will be utilized by the state inspection program.
- 4. Subchapter A, Part 352, Section 352.5 Holiday and Overtime Inspection Services. Fees and charges for overtime and state holiday inspection services will be established, as required by the Commission.
- 5. Subchapter A, Part 352, Section 352.7 Marking Inspected Products. Official state marks, devices and certificates of inspection will be utilized by the state inspection program.

In addition to temporary suspension in whole or in part of inspection services, as provided for in this regulation, the Director may, when he determines that the operator of any official establishment or any subsidiary therein, acting within the scope of his office, employment or agency, has threatened to forcible assault or has forcibly assaulted, intimidated, harassed or interfered with any program employees in or on account of his official duties under the law, assess a civil penalty in accordance with Section 47-4-130(b), S.C. Code of Laws, (1976) as amended.

**CHAPTER 27** 

Statutory Authority: 1976 Code Sections 47-4-30, 47-19-30, and 47-19-170

27-1022. State Poultry Products Inspection Regulation.

#### **Synopsis:**

These regulations are being promulgated to modernize, clarify and update existing regulations which govern, to the extent authorized by S.C. Code, Title 47, Chapter 4, the inspection of poultry products produced for intrastate commerce. These updated regulations are necessary to comply with the federal Poultry Products Inspection Act (21 USCA 454, Section 5) which establishes Federal-State Cooperative Poultry Inspection Programs. This is a grant program where federal funds for any year shall not exceed 50 per centum of the estimated total cost of the cooperative program. A cooperating state is required to adopt regulations "at least equal to" those adopted by the federal government. This regulation will, in effect, adopt the current Federal Poultry Products Inspection Regulations with some minor exceptions for some state specific requirements.

The Notice of Drafting was published in the State Register on August 22, 2025.

#### A. Definitions.

- 1. Commission means the State Livestock-Poultry Health Commission, Clemson University.
- 2. Director means the Director, Livestock-Poultry Health Programs, Clemson University.
- B. Adoption of Federal Poultry Products Regulations.

The United States Department of Agriculture, Food Safety and Inspection Service, Poultry Products Inspection Regulations, 9 CFR, Chapter III, Subchapter A, Parts 362 and 381 and Subchapter E. - (2) Subchapter A, Part 381, Subpart G, Facilities for Inspection, Section 381.38. State holidays as designated by the State Budget and Control Board will be utilized by the state inspection program.
- (3) Subchapter A, Part 381, Subpart G, Facilities for Inspection, Section 381.39. Fees and charges for overtime and holiday inspection services will be established, as required, by the Commission.
- (4) Subchapter A, Part 381, Subpart M, Official Marks, Devices and Certificates. Official state marks, devices and certificates of inspection will be utilized by the state inspection program.

#### **20 FINAL REGULATIONS**

The United States Environmental Protection Agency (EPA) promulgates amendments to the Code of Federal Regulations (CFR) throughout each calendar year. Recent federal amendments include revisions to New Source Performance Standards (NSPS) and National Emission Standards for Hazardous Air Pollutants (NESHAP) for Source Categories at 40 CFR Parts 60 and 63.

- (1) The Department proposes amending Regulation 61-62.60, South Carolina Designated Facility Plan and New Source Performance Standards, to incorporate by reference federal amendments promulgated from January 1, 2023, through December 31, 2024.
- (2) The Department proposes amending Regulation 61-62.63, National Emission Standards for Hazardous Air Pollutants (NESHAP) for Source Categories, to incorporate by reference federal amendments promulgated from January 1, 2023, through December 31, 2024.

The Department also proposes amending Regulation 61-62.60, Subpart CCCC, Standards of Performance for Commercial and Industrial Solid Waste Incineration Units, Subpart DDDD, Performance Standards and Compliance Times for Existing Commercial and Industrial Solid Waste Incineration Units, Subpart EEEE, Standards of Performance for Other Solid Waste Incineration Units for Which Construction Is Commenced After December 9, 2004, or for Which Modification or Reconstruction Is Commenced on or After June 16, 2006, and Subpart FFFF, Emission Guidelines and Compliance Times for Other Solid Waste Incineration Units That Commenced Construction on or Before December 9, 2024, to incorporate recent federal amendments to standards of performance under 40 CFR Part 60, Subparts CCCC and EEEE, and to update and clarify the applicability and scope of EPA emission guidelines provisions (found at 40 CFR Part 60, Subparts DDDD and FFFF) incorporated by the Department to ensure compliance with federal law.

The Department also proposes amending R.61-62.97, Cross-State Air Pollution Rule (CSAPR) Trading Program, and the SIP, to incorporate by reference recently promulgated federal amendments to the CSAPR NO<sub>X</sub> Annual Trading Program (found in 40 CFR Part 97, Subpart AAAAA) and the CSAPR SO<sub>2</sub> Group 2 Trading Program (found in 40 CFR Part 97, Subpart DDDDD) as necessary to maintain compliance with federal law.

The Department also proposes other changes to R.61-62, Air Pollution Control Regulations and Standards, as deemed necessary to maintain compliance with federal law. These changes include corrections or other changes for internal consistency, clarification, reference, punctuation, codification, formatting, spelling, and overall improvement to the text of R.61-62.

The Administrative Procedures Act, S.C. Code Section 1-23-120(H)(1), exempts these amendments from General Assembly review, as the Department proposes these amendments for compliance with federal law.

The Department had a Notice of Drafting published in the August 22, 2025, South Carolina State Register.

- (1) If the owner or operator of an incineration unit that commenced construction on or before December 9, 2004, makes changes that meet the definition of modification or reconstruction on or after December 29, 2025, the unit becomes subject to 40 CFR Part 60, Subpart EEEE and Regulation 61-62.60, Subpart EEEE, and this subpart no longer applies to that unit.
- (2) If an OSWI unit subject to this subpart is a very small municipal waste combustion unit or institutional waste incineration unit that commenced construction after December 9, 2004, and on or before August 31, 2020, and met the applicability of 40 CFR 60.2886(a)(1) before December 29, 2025, the unit is considered a new incineration unit and remains subject to the emission limitations of table 1 and applicable requirements of 40 CFR Part 60, Subpart EEEE and Regulation 61-62.60, Subpart EEEE until the unit becomes subject to an approved state plan or Federal plan implementing 40 CFR Part 60, Subpart FFFF.
- (3) If an OSWI unit subject to this subpart is a very small municipal waste combustion unit or institutional waste incineration unit that commenced reconstruction or modification on or after June 16, 2006, and met the applicability of 40 CFR 60.2886(a)(2) before December 29, 2005, the unit remains subject to the emission limitations of table 1 and applicable requirements of 40 CFR Part 60, Subpart EEEE and Regulation 61-62.60, Subpart EEEE until the unit becomes subject to an approved state plan or Federal plan implementing 40 CFR Part 60, Subpart FFFF.
- (4) If an OSWI unit subject to this subpart is a very small municipal waste combustion unit or institutional waste incineration unit that met the applicability of 40 CFR 60.2015 or 40 CFR 60.2550(a) as of December 29, 2025, then the unit remains subject to 40 CFR Part 60, Subpart CCCC and Regulation 61-62.60, Subpart CCCC, or Regulation 61-62.60, Subpart DDDD, or 40 CFR Part 62, Subpart IIIa until the unit becomes subject to the requirements of an approved state plan or Federal plan implementing 40 CFR Part 60, Subpart FFFF.
- (5) If the owner or operator of an existing incineration unit makes physical or operational changes to the unit primarily to comply with this subpart, then 40 CFR Part 60, Subpart EEEE and Regulation 61-62.60, Subpart EEEE do not apply to that unit. Such changes do not qualify as modifications or reconstructions under 40 CFR Part 60, Subpart EEEE and Regulation 61-62.60, Subpart EEEE.
- (D) This subpart does not apply to a unit if it is a rudimentary combustion device as defined in 40 CFR 60.3078.
